<p>On 03/23/2018 at approximately 1914 hours I arrived at 935 "C" Road, Town of Loxahatchee Groves, Palm Beach County, Florida in reference to a 911 call of a fight. I met with a white male wearing a red T-shirt and blue shorts who identified himself as Mr. Jeffrey R. Sargent. Mr. Sargent who at first told me that incident was all verbal and nothing happened and everything was ok. Mr. Sargent gathered up his golf clubs and started to walk away towards the entrance to the pasture. As Mr. Sargent approached the gate to the pasture area another white male wearing a white Stetson hat, tan long sleeve shirt and blue jeans (who was later identified as Mr. Bradley S. Rea) approached the pasture area. Mr. Rea began a verbal altercation with Mr. Sargent while he was attempting to walk away. Due to the distance all I could hear was indistinct yelling.</p> <p>I met with Mr. Rae who told me that he came into the pasture area to ask Mr. Sargent what is going on. He said that he got into a confrontation with Mr. Sargent the day before because he found out that Mr. Sargent did 12 years for murder. Mr. Rea stated that he asked Mr. Sargent to vacate the property. Mr. Rea told me that today he asked Mr. Sargent what he was doing, and he was then pushed by Mr. Sargent so hard that he fell to the ground in a summersault. Mr. Rea went on to say that he was flipped over backwards. Mr. Rea responded with "really Jeff?" Mr. Rea said that Mr. Sargent continued to get in his face. Then Mr. Sargent pushed him over again, Mr. Rea went on to say that he is young, strong and Mr. Rea said that he was not the aggressor.</p> <p>Mr. Sargent returned to the pasture area to give his version of what occurred. Mr. Sargent stated that he was hitting golfballs on the property where he is renting. The property owner's boyfriend Mr. Rae came out to where he was and started harassing and threatening him. Mr. Sargent stated that he repeatedly asked Mr. Rae to leave him alone; Mr. Rae continued to get louder and more aggressive. Mr. Rae took a swing (attempted to punch) at Mr. Sargent who blocked the punch. Mr. Rae picked up a golf club and Mr. Sargent said that he told him to go ahead. Mr. Rae threw down the golf club acting like he was done. Mr. Sargent stated that Mr. Rae got closer to him acting like it was over yelling at him that he has 30 days to move and once he got closer Mr. Rae took another swing at Mr. Sargent and Mr. Sargent pushed Mr. Rae away from him. Mr. Sargent stated that he wants to prosecute for Battery.</p> <p>I spoke to the witness Mr. Ryan Payne who told me that "Brad" (Mr. Rae) was the one who pushed "Jeff" (Mr. Sargent) first as well as started the argument. Mr. Rae put his hands on Mr. Sargent multiple times. I advised Mr. Rae that he is being placed under arrest for Battery per F.S.S. 784.03(1)(a)(1) due to the information gathered in this case. Mr. Rae was handcuffed with 2 interlocking sets of cuffs due to medical issues with his back and shoulders. Mr. Rae was transported to the Palm Beach County Western Region jail for processing.</p>
