





BBPD Communications personnel dispatched units to Major's Draft House, 1403 W. Boynton Beach Blvd, Boynton Beach, Palm Beach County, FL in reference to a report of a strong armed robbery. As units converged upon the area, the suspect vehicle description of a white Dodge Durango was relayed. Additionally, the caller reported having observed the suspect, a large B/M with dreadlock style hair, wearing a black shirt and jean shorts, take a purse then flee in the aforementioned vehicle in a northbound direction of travel on N. Congress Avenue. Approximately 1-2 minutes later, Ofc. Roberts observed the suspect vehicle traveling eastbound on W. Gateway Blvd, just east of N. Congress Avenue. At that time, a felony investigatory traffic stop was initiated by Ofc. Roberts who activated his emergency equipment (lights and sirens) on his marked police vehicle. Verbal commands were relayed to the driver, later identified as DEFENDANT BRANDIE NICOLE GABRIEL in an effort to gain her compliance. As she was called back to Ofc. Robert's patrol vehicle, Sgt. Kautz was positioned in the left turn lane on the westbound side of Gateway Blvd, just east of the stopped suspect vehicle. GABRIEL disregarded the lawful commands instead opting to proceed around the front of her vehicle towards the front passenger side door. Sgt. Kautz observed her movement towards the front of her vehicle and proceeded to turn into the access road to the Compson Place multi-use development. GABRIEL was able to re-enter the vehicle on the passenger's side, while passenger/CO-DEFENDANT PIERRE REVOL moved from the front passenger seat to the driver's seat where he assumed control of the vehicle. With both DEFENDANTS in the vehicle, REVOL proceeded to flee the scene and in doing so, struck the front right portion of Sgt. Kautz's marked patrol vehicle causing extensive damage to the front bumper and push-bar.

REVOL then departed the scene of the motor vehicle crash involving property damage and proceeded to travel eastbound in the westbound lanes of traffic for approximately .5 miles. REVEL then continued to drive at a high speed and in a manner which demonstrated a wanton disregard for the safety of persons or property. The vehicle was pursued by primary officer, Ofc. Roedel at which time the suspect vehicle entered interstate 95 at Gateway Blvd traveling northbound and proceeded into the city limits of Lake Worth, Florida where the suspect vehicle struck an unoccupied parked vehicle (white Ford 4Dr FL tag M036TP) in the 900 block of 10th Ave South becoming disabled. At that time, both occupants, CO-DEFENDANT REVOL and DEFENDANT GABRIEL fled from the vehicle and were apprehended a short time later by Ofc. Roedel and K9 Ofc. Adams. Two eyewitnesses, WITNESS JOSEPH ZAPPULLA and WITNESS BRANDYN GERSTEIN along with VICTIM CHRISTINE CAPOZZIELLO were transported in separate vehicles to the scene where all three positively identified REVOL as the subject who was responsible for the unlawful taking of the victims purse which had been taken off her barstool. Both GERSTEIN AND ZAPPULLA also advised they observed REVOL enter the passenger side of the suspect/getaway vehicle which was being operated by DEFENDANT GABRIEL at the time of theft. Based on the above facts resulting from this investigation, probable cause exists to charge DEFENDANT GABRIEL with 1F count Grand Theft, 1F count Conspiracy and 1M count Resisting Arrest without Violence. GABRIEL was arrested and TOT PBCJ.
