On the above date at approximately 2152 hours, Jupiter police officers responded to a crash that occurred on North Alternate A1A at the intersection with North Old Dixie Highway, in the Town of Jupiter, Palm Beach County, Florida.

A 2008 Dodge pickup bearing Florida license plate 173PZM collided with a 2015 Toyota pickup truck bearing Florida license plate HFA42. The Dodge pickup was registered to Brandon Miele. The front seat passenger was identified as Chantelle Burgoyone. Burgoyone stated to MPO Salvemini on scene that Miele was driving. The other vehicle was determined to be operated by Troy Faminial. Troy Faminial's sister, Angelica Faminial was in the front passenger seat. Both were transported by ambulance to Jupiter Medical Center with moderate injuries.

There were two marks on the windshield consistent with both the passenger and driver hitting their heads on the windshield. The one on the passenger side had long hair that was similar to Burgoyone's. The mark on the driver's side was significantly higher in the windshield, indicating that a taller person had struck their head. MPO Salvemini and later Sergeant Drown both confirmed to me that Miele was obviously intoxicated. Miele was at first sitting on the curb next to Burgoyone. A short time later, Miele walked by me with a neck brace on and went towards the ambulance Burgoyone was being transported in. As Miele walked by me, I could smell a very strong odor of an unknown alcoholic beverage coming from Miele. Miele was not being assisted by any medics on scene. Miele entered the ambulance.

I found out a short time later that Fire Rescue was planning to take both Burgoyone and Miele to St. Mary's Medical Center. I determined that based on the statements of Sergeant Drown and MPO Salvemini, I had probable cause to arrest Miele for DUI. There was no medical reason to take Miele to St. Mary's Medical Center, which is a trauma center. I went to the ambulance and confirmed medics had no specific reason to

transport Miele to St. Mary's Medical Center. At that point I ordered Miele to exit the ambulance. Miele complied. I began to speak to Miele. I could see his eyes were extremely bloodshot and glassy. Miele's eyelids were droopy. Miele had the strong odor of an unknown alcoholic beverage on his breath. I advised Miele he was under arrest for DUI. Miele indicated he did not understand. I explained it to him. I then had Miele sit on a police car bumper nearby and I asked that Palm Beach County Fire Rescue send another ambulance for Miele to be transported to the Jupiter Medical Center for medical clearance. Miele's speech was heavily slurred.

I read Miele his Miranda Rights from a prepared text. Miele indicated that he understood. I asked Miele to tell me what happened, with his rights in mind. Miele stated he was driving from a wedding on Riverside Drive in the left hand lane going west. Miele pointed towards US Highway 1 when asked where Riverside Drive was and pointed out the southbound lanes which are both the opposite location from where Riverside Drive actually is. Miele stated that the other vehicle was in the wrong lane. Miele stated the wedding started at 345 and that he had come straight from the wedding. Miele stated that he had consumed 5-6 beers at the wedding. I asked Miele how impaired he felt on a scale of 1-10. Miele stated, "6". Upon the arrival of a Palm Beach County Fire Rescue ambulance, Miele was transported to the Jupiter Medical Center. Sergeant Drown went with Miele in the ambulance and I followed behind.

MPO Salvemini's investigation determined that Miele was likely in the wrong lane of travel, coming north on North Alternate A1A from the area of the wedding on Riverside Drive. The other vehicle was coming south on North Alternate A1A from southbound North US Highway 1. Troy and Angelica Faminial work in Tequesta, which from the location of the crash is north on North US Highway 1. Miele violated the other vehicle's right of way and struck it in a near head on manner. Neither occupant of the other vehicle displayed signs of impairment.

Miele was medically cleared within about 1 hour. From speaking to Miele's doctor, I knew that the time frame would be relatively short, so I determined that a breath sample would not be impractical or impossible. Miele's speech remained very slurred at the hospital. Miele asked me the same questions several times, including how long he would be in custody for, where his wallet and phone was (I had taken them from him on scene and told him when I did), and repeating that he was sure the other vehicle was in the wrong lane.

Upon receiving medical clearance paperwork for Miele, I transported him to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period. I then requested that Miele provide a sample of his breath. He refused. I read Implied Consent from a prepared text, which Miele indicated he understood. Miele again refused to provide a sample of his breath again at 0050 hours. Miele advised that he remembered me reading him his Miranda Rights and did not need to hear them again.

He is holding a small drink that appeared to be in a clear cup with a red liquid and short straw, consistent with an alcoholic beverage. Miele only admitted to drinking beers during his interviews. I placed the photo card in evidence for future use in this case along with my in car video from my transport of Miele.

Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
