

Lehman became aggressive with employees and patrons who were trying to enjoy the establishment. Witness advised he was trying to fight him and the other bouncer of the business.</p> <p>I observed Lehman to have blood shot eyes, slurred speech, and constantly swaying due to him being intoxicated. Lehman did state he had been drinking.</p> <p>Due to the above facts and statements I find probable cause to charge Brandon Lehman with (1) count of F.S.S 856 011 Disorderly Intoxication.</p>
