On the 16 day of June, 2018 at 00:52 (Specifically include facts constituting cause for arrest.)

The following occurred within the City of Delray Beach, Palm Beach County, FL.

On 06/15/18 at 2130 hours, officers were dispatched to 718 George Bush Blvd. in reference to a white female wearing a white shirt and white shorts (who is later identified as Brandy Jade Masters) armed with a knife. The white female was yelling out racial slurs and threatening to harm people. The officers attempted to locate the white female but were unable to locate her.

At 2241 hours, I was dispatched to 718 George Bush Blvd. in reference to the same white female from the previous 911 call earlier that evening. I spoke with Matt Michell (complainant) who stated that he observed Masters yelling and making threats to harm people. Michell stated Masters was armed with a knife during the incident. Michell stated Masters left the area on foot northbound on NE 8th Ave. after Masters left the area, an unknown women approached Michell stating Masters dropped a note on the ground before she left the scene. Michell stated Master`s note contained disturbing content and he wanted to turn the note over to the police. I took possession of the note.

The note contained a name of Josh Baker (victim) along with Baker`s home address and phone number. The note contained a plan to get the victim fired from his job and while carrying a loaded gun. With the information above, I conducted a follow up investigation at 1010 NE 8th Ave Apt 37F. While approaching the residence, I heard a women yelling from inside the residence. I saw Baker and Masters on the couch arguing. I knocked on the front door and Masters answered the door. Masters was covered in blood and I asked her who else was in the home. Masters stated her boyfriend, Josh Baker, was also present in the apartment. Baker came outside with lacerations to his left hand, head, and a puncture wound to his left forearm. Baker`s face was swollen and bruised. Baker stated the argument started over Masters accusing him of cheating. Baker stated he and Masters have been dating for 1-2 months and live at separate addresses. Baker stated the

argument turned physical and he was struck in the face with metal objects and was stabbed with a knife by Masters. Baker stated the metal objects was similar to a rod and possibly be a pair of large BBQ tongs. Baker stated when Masters attacked him with a knife, he attempted to defend himself by pushing Masters onto the ground in the bathroom near the front entry door. Baker stated Masters fell to the ground holding the knife and struck her head on the bathroom floor. Baker stated he disarmed Masters and threw the knife outside onto the patio. Baker provided a sworn written statement for the incident. Delray Beach Fire/Rescue responded to the scene and transported Baker to Bethesda Memorial Hospital for further treatment. Baker required stiches for his lacerations. Baker also had severe swelling near his eyes and face from being struck with the metal BBQ tongs.

Masters was placed in handcuffs due to her not complying with officer's orders. Masters had a laceration to the back of her head and had bruising on her right forearm. Masters appeared to be under the influence of alcohol. Post Miranda Warning, Master's stated she and Baker was in a physical altercation and she admitted attacking Baker with a knife because Baker cheated on her. Masters also admitted to writing a note at the Sail Inn (657 George Bush Blvd) earlier in the night. The Sail Inn is across the street where the earlier calls for service took place. The note contained writings of "187:find my gun!", "I wait for dumpsters by ur car" and "coming to hate lol loaded gun". A knife was recovered on the patio by Crime Scene and collected as evidence. The note was collected and entered as evidence. Masters required to have staples administered on the back of her head. I determined Masters to the primary aggressor in the incident. The above incident was captured on my body worn camera.

Due to the above stated facts and statements, Probable Cause does exist to charge Brandy Jade Masters with Aggravated Battery Cause Bodily Harm or Disability pursuant to F.S.S 784.045(1A1) and Aggravated Battery with a Deadly Weapon pursuant to F.S.S 784.045(1A2).
