ON 10/28/16 AT 2100 HOURS, MYSELF, CPL. VILLIERS AND SGT. KENNEDY HAD JUST FINISHED PATROLLING THROUGH THE WELLINGTON PARK AND RIDE LOCATED AT 2176 WELLINGTON GREEN DR WELLINGTON FLORIDA, WHICH IS A KNOWN HANGOUT FOR SUBJECTS TO PULL INTO AND USE ILLEGAL NARCOTICS AMONG OTHER THINGS.

WHILE WE WERE STILL PARKED IN THE PARKING LOT AND OUT OF OUR VEHICLES HAVING A CONVERSATION, WHEN WE OBSERVED A TAN VOLKSWAGEN SEDAN ENTER THE PARKING LOT AND DRIVE PAST US. THE VEHICLE HEADED TO THE FAR EAST END OF THE PARKING LOT AND PULLED INTO A PARKING SPACE, AND TURNED OFF THE HEADLIGHTS. AFTER WATCHING THE VEHICLE IN QUESTION FOR A FEW MINUTES, WE OBSERVED NO ACTIVITY AND NO ONE EXITED. WE DECIDED TO APPROACH THE VEHICLE AND MAKE CONTACT WITH THE OCCUPANTS. AS WE APPROACHED THE VEHICLE, I IMMEDIATELY NOTICED A ODOR OF MARIJUANA COMING FROM THE INTERIOR OF THE VEHICLE. I MADE CONTACT WITH THE DRIVER WHO WAS IDENTIFIED BY HER FLORIDA DRIVERS LICENSE AS BRANDY WRIGHT. I ASKED WRIGHT WHY THEY WERE PARKED WITH THEIR LIGHTS TURNED OFF, AND SHE ADVISED SO THEY COULD TEXT. I HAD WRIGHT EXIT HER VEHICLE AND SIT ON THE GROUND NEXT TO MY TRUCK. WHILE SPEAKING WITH WRIGHT, I HEARD THE FEMALE PASSENGER LATER IDENTIFIED BY HER FLORIDA DRIVERS LICENSE AS SAMANTHA SCHEBECE SCREAMING LOUDLY. I THEN OBSERVED SGT. KENNEDY WITH HIS FIREARM DEPLOYED AND POINTING AT THE REAR PASSENGER WHO WAS LATER IDENTIFIED BY HIS FLORIDA DRIVERS LICENSE AS JEREMIAH BRIDGEWATER. SGT. KENNEDY WAS ADVISING BRIDGEWATER MULTIPLE TIMES TO SHOW HIM HIS HANDS. I THEN APPROACHED THE PASSENGER SIDE OF THE VEHICLE AND OBSERVED BRIDGEWATER MOVING AROUND AND NOT COMPLYING WITH COMMANDS TO SHOW US HIS HANDS. I REACHED INTO THE VEHICLE AND UNLOCKED THE PASSENGER DOOR AND OPENED IT. I ORDERED BRIDGEWATER TO EXIT THE VEHICLE WITH HIS HANDS VISIBLE AND UP IN THE AIR. BRIDGEWATER THEN EXITED THE VEHICLE. I ADVISED BRIDGEWATER TO TURN AROUND AND PLACE HIS HANDS ON THE CAR BUT HE REFUSED TO COMPLY. MYSELF AND CPL. VILLIERS FORCED BRIDGEWATER AGAINST THE VEHICLE AND ATTEMPTED TO PLACE HIM IN HANDCUFFS, BUT HE PULLED AWAY FROM BOTH OF US. AS WE WERE DEALING WITH BRIDGEWATER AND TRYING TO TAKE HIM INTO CUSTODY, SCHEBECE EXITED THE VEHICLE AND ATTEMPTED TO RUN OVER TO MYSELF AND CPL. VILLIERS. SGT. KENNEDY PLACED HIS ARM IN FRONT OF SCHEBECE IN ORDER TO STOP HER, BUT SHE CONTINUED TO TRY AND GET PAST HIM AND REFUSED TO COMPLY. SGT. KENNEDY THEN PLACED HER INTO CUSTODY AS SHE WAS FLAILING HER ARMS AND STILL REFUSING TO COMPLY. MYSELF AND CPL. VILLIERS WERE ABLE TO TAKE BRIDGEWATER INTO CUSTODY WITHOUT FURTHER INCIDENT. UPON SEARCHING THE VEHICLE, I RECOVERED A SMALL POUCH WHICH CONTAINED APPROXIMATELY .5 GRAM OF HASH OIL, LOCATED IN THE DRIVERS DOOR POCKET. THE POUCH WAS LABELED "CBD DAB WAX250 MG" AND HAD AN ORANGE PRICE LABEL OF \$59.99. UPON SHOWING THE HASH OIL TO WRIGHT, SHE ADVISED SHE BOUGHT IT AT EXOTIC VAPES WHICH IS LOCATED AT 13833 WELLINGTON TRACE IN WELLINGTON FLORIDA AND THAT IT DIDN'T CONTAIN ANY (THC). THE HASH OIL TESTED POSITIVE USING A DUQUENOIS REAGENT FIELD TEST KIT AND TURNED DARK PURPLE UPON TESTING. I RECOVERED A BLUE MULTICOLORED GLASS PIPE WHICH CONTAINED MARIJUANA RESIDUE IN THE GLOVEBOX OF THE VEHICLE. CPL. VILLIERS RECOVERED THREE GRAMS OF MARIJUANA ON THE FLOORBOARD NEXT TO THE LEFT FOOT OF BRIDGEWATER. CPL. VILLIERS ALSO RECOVERED A SMALL MULTICOLORED GLASS PIPE FROM THE PURSE OF SCHEBECE WHICH CONTAINED MARIJUANA RESIDUE. THE THREE GRAMS OF MARIJUANA TESTED POSITIVE USING A DUQUENOIS REAGENT FIELD TEST KIT.

BASED ON THE EVIDENCE RECOVERED, WRIGHT WAS PLACED UNDER ARREST FOR POSSESSION OF HASH OIL AND POSSESSION OF PARAPHERNALIA. BRIDGEWATER WAS PLACED UNDER ARREST FOR RESISTING OFFICER WITHOUT VIOLENCE AND POSSESSION OF MARIJUANA UNDER TWENTY GRAMS. SCHEBECE WAS PLACED UNDER ARREST FOR POSSESSION OF PARAPHERNALIA AND RESISTING OFFICER WITHOUT VIOLENCE. ALL THREE SUBJECTS WERE TRANSPORTED TO THE WESTERN DETENTION CENTER. THIS CASE IS CLEARED BY ARREST. NO FURTHER.
