PROBABLE CAUSE

On August 7th, 2017 I Trooper Lucas M. Tavares (3913/1555) with the Florida Highway Patrol was on active patrol in Palm Beach County, Florida. I was in a marked FHP unit equipped with overhead emergency lights and external siren. At approximately 8:42 p.m. I was traveling northbound on Interstate 95 when I received a call about a motor vehicle crash that took place on Interstate 95 and Forest Hill Blvd. My dispatch advised me that a white female fled from the scene of the accident eastbound on Forest Hill Blvd. They also stated that the suspect was wearing a white dress with stripes.

At approximately 8:44 p.m. I arrived on scene. I stopped out with pedestrians located at the intersection of Interstate 95 and Forest Hill Blvd. I asked them if they saw a white female running and they stated that she ran east. That's when I proceeded east and saw a white female running on the Northside of the roadway. There was a deputy (Deputy Moral) with Palm Beach County Sheriff's office who saw her running and stopped out with her. I then pulled in behind and immediately detained the subject. The subject was later identified as Brenda J. Paixao by her Florida's Driver's License: (P-200-070-74-548-0). I asked the subject if she was ok and she stated yes. While talking to Ms. Paixao I could detect a very strong odor of an unknown alcoholic beverage on her breath that grew stronger as she spoke. Ms. Paixao had blood shot and watery eyes. Ms. Paixao appeared to be heavily intoxicated.

Also on scene was the other driver who followed the subject on foot. The other driver was identified as Sergio Cruz. Mr. Cruz stated that he was driving eastbound on Forest Hill Blvd. He stated he was at the light, at the intersection of Forest Hill Blvd and Interstate 95. He stated that when the light turned green he was violently struck from behind and then the vehicle that struck him continued eastbound on Forest Hill Blvd. He stated that the vehicle that struck then made a left turn onto the entrance ramp to Interstate 95 from Forest Hill Blvd then ran off the road and struck a traffic sign.

I then relocated to the scene of the accident where I observed a whit in color Ford on the right grassy area of the entrance ramp to Interstate 95 from Forest Hill Blvd. The vehicle had heavy front end damage, consistent with a rear end collision and was against a traffic sign. The vehicle was a white 2015 Ford Focus with Florida Tag: (HCLR07) attached. The vehicle was registered to the subject Brenda Paixao.

I then read Ms. Paixao the Miranda Warning and she stated she understood. I then took Ms. Paixao out of my vehicle and advised her that we were done with the crash investigation and going into a criminal investigation for DUI. I then requested Ms. Paixao to perform Field Sobriety Exercises. She stated that she would.

Field sobriety was conducted roadside. Based upon my observations Ms. Paixao was placed under arrest for was placed under arrest for DUI pursuant to Florida Statute 316.193.1 at 09:05 PM. Ms. Paixao was then searched by Tpr. White (1687) and placed in my patrol vehicle and transported to the Palm Beach County Jail in which she arrived at 09:20 PM. After the defendant's 20min observation, the defendant was then given the opportunity, to provide a sample of her breath which she did not consent to provide. The defendant was then read implied consent in which she again refused to provide.

Tpr. C. Mitchell (1385) worked the crash portion of this investigation. Statements were taken by Tpr. A. Parent (1721). Tpr. C. Mitchell located Marijuana within Ms. Paixao's vehicle and was charged with leaving the scene of a crash by tpr. C. Mitchell.

Video of the traffic stop, roadsides and transport are available through the FHP custodian. The above incident did occur in Palm Beach County, Florida.
