On Thursday, 6SEP18 around 0351hrs, I arrived at the single story, single family home at 356 Flagler Blvd, in the Town of Lake Park, Palm Beach County, in response to a domestic dispute. As I pulled up, Deputy D Booras, ID #27529, was standing in the front yard speaking with a white male later identified as Zake Broan Pearson, d.o.b. 10/15/1994. Inside the house was an intoxicated, white female Brenda Lynne McGuire, d.o.b. 4/29/1963, and white male Christopher John Tirillo, d.o.b. 4/12/1969, who was passed out on the living room floor, oblivious to the commotion around him.

White male Mathew Joseph Tirillo, d.o.b. 6/22/1975, who lives at the address had left before our arrival. McGuire initially called police to complain that Mathew, whom she claimed is her boyfriend, "threw me through a door". The front door of the house, which she said was the door, had no dents in it, or other marks to indicate someone had struck it. McGuire claimed she struck it with her hip, but refused to give a statement, allow us to photograph her, or to be treated by fire rescue. McGuire and her step son, Pearson, claimed this event was the culmination of long time abuse, but neither would give a statement, or explain why there was broken glass on the kitchen floor.

While trying to get an account from McGuire, her cell phone rang, and she spoke with Tirillo briefly, telling him, "the cops are here." She claimed he wanted to speak with the police, but hung up on him. A few minutes later, he called again, and at Pearson's urging, she handed me her phone. I advised him of what I'd been told, and Tirillo emphatically denied the story saying he was sleeping in his room when he was awakened 'by someone punching me in the face.' I asked if he would give that in a sworn statement, and he immediately said, "yes", and agreed to return home. He was brought home by his current girlfriend, white female Adrianna Vale, d.o.b. 1/15/1980, who lives in Palm Beach Gardens.

Vale told me that the Tirillo brothers, and Pearson (Mathew's son) were out drinking all night on Singer Island, where an argument erupted between Mathew and his son, causing Pearson to leave them, and start walking home. She received several text messages, and calls from Mathew, Pearson, and Christopher, during the evening. They eventually all made it home after 1:00 a.m. Around 0240hrs, Vale said that Mathew arrived at her house unannounced, and told her that he was sleeping when he was awakened by McGuire punching him in the face. She overheard Mathew's phone conversations with McGuire and me.

McGuire, but Vale is currently Mathew's girlfriend, and has been for several months. Mathew says that he allows McGuire, his ex-girlfriend with whom he lived with in the past, to stay there "until she gets back on her feet." McGuire told me that she is trying to move out when I first arrived. Pearson just moved from Colorado, and is temporarily living at the house. Chris Tirillo arrived from Arizona this afternoon. The three men went drinking on Singer Island, and an argument erupted between Mathew and his son. When they returned home, McGuire was very upset with Mathew, and went into Mathew's room and hit him in the face. There was a very slight swelling to Mathew's cheek. This most likely angered Mathew to the point where he attempted to eject McGuire and Pearson from the home, leading to the accusation of him battering McGuire. Mathew left for Vale's house, and the police arrived within the hour, because it is unclear what time the alleged batteries occurred.

Deputy Booras got a video taped statement from Mathew, and photographed him. Upon returning to the District 10 station, I placed the SD card with the photos into evidence. Vale gave a detailed written statement of what she had seen and heard. After getting the statements, we placed McGuire under arrest because McGuire did actually and intentionally touch or strike Mathew Joseph Tirillo against the will of Tirillo and Tirillo was a family or household member of McGuire, contrary to Florida Statute 784.03(1) and 741.283 (1 DEG MISD). She was transported to the District 10 station where I completed my arrest paperwork, before she was transported to the Palm Beach County Jail.
