On June 20, 2018 at 0012 hours, I responded to 21445 Town Lakes Drive Apt. 337 in reference to a battery investigation.

Upon arrival I met with the complainant, Emilia Cruz. Cruz advised that she was just in a physical altercation with her roommate, Brendan Morrison. Cruz stated that when she arrived at her residence she told Morrison that she wanted him to leave and that he was no longer welcome. According to Cruz, she has let Morrison stay at her residence multiple times over the course of several months and has currently established residence in the apartment. Cruz stated when she told Morrison to leave the residence, he became physical with her by grabbing her and pushing her against the front door. Cruz also advised that Morrison pushed her out of the front door and locked it, preventing her from entering the residence. Morrison stated that she could not re-enter the apartment again due to the fact her key was still inside the residence from when the altercation occurred. It should be noted, Cruz's key was later found on the floor near the front door inside the residence. Cruz advised that during the altercation, Morrison put her into a headlock for a few seconds as well. It should be noted, there was no visible redness or swelling; however, she had a multiple strands of hair that were pulled out from when the altercation occurred. Cruz advised that at no point during the altercation did she ever strike Morrison. It should also be noted, Cruz refused medical attention.

I then spoke to Morrison who was visibly intoxicated and continued to drink alcohol during the investigation. Morrison advised that he has been staying at the residence for approximately eight months. According to Morrison, when Cruz arrived at the residence she punched him in the face and knocked over his television. Morrison stated after she punched him in the face she called the police. According to Morrison, he never became physical with Cruz at any time. Morrison stated that Cruz's plan for him leave to the residence was to come into the apartment to punch him in the face, and call the police. Morrison also could not provide an explanation of why Cruz was locked out of the

apartment. It should be noted, Morrison did not have any physical injuries to his face from the alleged battery from Cruz.

I then spoke to Cruz again. Cruz confirmed that she never punched Morrison in the face and that the hair was pulled out from when Morrison grabbed and pushed her multiple times. It should be noted, I did not notice any redness on Cruz's hands that would be consistent to punching Morrison in the face.

During the course of my investigation, Officer Bruggeman had to tell Morrison multiple times to remain silent as to not interfere with my investigation. Morrison was purposely antagonizing and laughing obnoxiously at Cruz while I was speaking to her. It should be noted, Cruz had to stop multiple times while attempting to give a statement due to Morrison's erratic behavior. Morrison continued to obstruct my investigation. After the fifth time of telling Morrison to remain silent, Officer Bruggeman detained Morrison for Resisting an Officer Without Violence (See Officer Bruggeman's supplement for further).

Based on Cruz's statements, strands of hair missing from her head which were consistent to a physical altercation, and inconsistent statements provided by Morrison, I developed probable cause to arrest Brendan Morrison for Simple Battery, pursuant to F.S.S. 784.03. Morrison was arrested due to the fact he grabbed and pushed Cruz multiple times during a physical altercation causing her hair to be pulled out from her head. I then additionally charged Morrison for Resisting an Officer Without Violence after he obstructed Officer Bruggeman, a law enforcement officer of the Boca Raton Police Department, in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, pursuant to Florida Statute 843.02.
