wife, Tiffany Shea Conelly (W/F, DOB: 10/23/82) had gotten into an argument regarding a a yard sale. He would not go into anything further about the disagreement. Beaty stated that he had been battling suicidal thoughts and was supposed to be admitted into a program tomorrow at JFK North. Beaty stated that he had not been taking one of his medications and that he tried to hang himself.

I then made contact with Conelly who stated that they were arguing over a yard sale. Conelly stated that Beaty had become very loud and aggressive and she was scared and feared Beaty because he was throwing things around the house. The house appeared to be in disarray with miscellaneous items scattered around the floor. Conelly stated that she was in the kitchen, leaned up against the door leading to the garage and covered her ears in fear of Beaty. Conelly stated that her back was facing Beaty when he then came up behind her, grabbing her neck and in the process, scratched her face near her right eye. It should be noted that I observed what appeared to be a red scratch mark on Conelly's face. The scratch mark was approximately 1 inch in length and was on her right upper cheek bone near her right eye. The injury and it's location on her face corroborated Conelly's statements regarding the physical altercation between her and Beaty. I did not observe any redness or bruising on the back of her neck.

Conelly also showed us a video she had recorded on her phone just prior to calling the police department, which showed Beaty trying to harm himself and being verbally aggressive towards Conelly. The video showed Beaty standing on a chair in the garage with an extension cord around his neck that was tied to the garage door motor. I went into the garage and observed the extension cord hanging from the garage ceiling. There were visible strands of hair that were stuck in the knot of the cord. The hair appeared to be similar to Beaty's. Conelly's aunt, Carmen Powers (W/F, DOB: 04/18/51) was also in the house and was woken up by and witnessed the yelling. Powers heard them arguing over the garage sale however; did not observe anything physical between Conelly and Beaty. Powers also stated that she feared Beaty because of his behavior.

Based on the totality of the circumstances, to include the statements of all parties involved, the injury Conelly sustained, I have probable cause to arrest and charge Brennan Chase Beaty with Battery-Simple (Domestic Violence) pursuant to F.S.S. 784.03(1)(A)(1).

Beaty was transported to the Palm Beach Gardens Booking area for processing, and then subsequently transported to the Palm Beach County Jail without incident. Conelly was given a victim notification form and rights and remedies packet in which she signed.
