Palmetto Park Rd. in reference to a simple battery.</p> <p>Upon my arrival, I made contact with Joshua Nubine who stated that Brett Jowers pushed him and punched him in the stomach. It should be noted that Nubine and Jowers are both homeless (at large) and both reside under the pavilion at the beach located at 1 N. Ocean Blvd. The physical altercation transpired at this location (1 N. Ocean Blvd).</p> <p>According to Nubine, he advised Jowers that he no longer wanted to be friends anymore due to personal reasons. Jowers then proceeded to throw all of Nubine's personal belongings into the sand. According to Nubine, when he asked Jowers to stop throwing his belongings and attempted to obtain his belongings, Jowers pushed him into the sand. When Nubine stood up from the sand, Jowers then punched him in his stomach 4-5 times, which caused Nubine to slip on a concrete ledge (on the beach) and fall downward into the sand (face forward). Nubine stated that he hurt his right hand when he fell to the floor but he did not sustain any injuries or bruises. According to Nubine, when he fell forward he tried to use his hands to stop his fall but failed thus his body weight hurt his right hand. Nubine stated that Jowers advised him that he had a knife in his back pack and would use it if necessary but never pulled the knife out on him. Nubine also stated that he did not visually observe the knife.</p> <p>Nubine stated that Jowers's girlfriend (April Butler) was also on the beach but she did not touch him and he did not intentionally touch her. According Nubine, when he fell downward onto the sand, the front of his head hit Butler's lip. Nubine stated that he immediately left the area because he was afraid and walked towards 711 due to the rainy weather. It should be noted that Nubine did not obtain his belongings.</p> <p>I then made contact with Michael Laura who was an independent witness. Laura resides</p>

under the pavilion at the beach at 1 N. Ocean Blvd. Laura stated that he witnessed the entire physical altercation. Laura stated that he is friends with both Jowers and Nubine. Laura gave the same account as Nubine and stated that Jowers pushed and punched Nubine in the stomach. According to Laura, Nubine did not retaliate and attempt to touch or hurt Jowers or Butler. Laura declined to complete a written statement form.

Officer Gannon and I then searched the area and located Jowers and Butler at 500 E. Palmetto Park Rd. Jowers stated that although he took Nubine's belongings and threw the items on the sand, he denied ever touching Nubine. It should be noted that Butler did have a small cut on the inside of her mouth. Butler stated that Nubine was trying to obtain his belongings from the sand and he slipped on a ledge, fell forward and hit her lips. Butler stated that she never touched Nubine. It should also be noted that when I searched Butler's and Jower's bag pack via verbal consent, I located a knife in the back pack. Jowers stated that he keeps the pocket knife for protection but never attempted to use it on Nubine.

Based on my investigation, Brett Jowers is the primary aggressor in this altercation as he pushed and punched Nubine in the stomach and threw his belongings into the sand. Brett Jowers is being charged with Simple Battery under F.S.S 784.03. Jowers was placed into handcuffs and arrested at 2149 hours. Handcuffs were checked for tightness and double-locked. He was transported to BRPD for processing and then further transported to Palm Beach County Jail.

I took pictures of Butler's lip, which were submitted into BRPD evidence.
