**Narrative:**

On Saturday the 20th day of August, 2016, at approximately 2005hrs I arrived at 9106 Mahogany Dr. (LaCosta) in reference to a domestic disturbance. Upon my arrival and after knocking on the door a male, later identified via his Florida Drivers license as Brett S. Rose, answered the door and appeared to be out of breath and his skin was "clammy".

Brett appeared to be surprised by police arrival and stated that he had only been arguing with his girlfriend, later identified via her Florida Drivers License as Meaghan E. Lipanka, over her set of keys that he might have lost earlier in the day. Brett stated that they both had been drinking and Meaghan was simply "over-reacting" in regards to the "lost keys".

I then went into the residence to speak with Meaghan who also appeared to be out of breath and "clammy". When I use the word "clammy" I am referring to the skin being red and the pores open as if some physical exertion had taken place. Meaghan stated that when the two arrived home he began to yell at her for no apparent reason. Meaghan stated that it first became physical when Brett pushed her onto the couch and with an open hand, struck her in the left buttock. This left a large welt in the shape of a hand; a photograph was taken of this injury. Meagan stated that Brett becomes violent when he drinks.

Meaghan went on to say that she got up from the couch and went into the couples bedroom where she laid in the bed. Meaghan stated that Brett then entered the room and climbed on top of her, pinning her to the bed and choking her with both of his hands. Meaghan stated that this choking occurred for several minutes - on and off. Although there was no petechial hemorrhaging present, there was visible bruising along both sides of the neck; photographs of these injuries were also taken. Meaghan stated that she doesn't believe she lost any consciousness but made mention she was definitely struggling to breath. Meaghan refused any medical attention. Meaghan stated that Brett eventually left the room at which time she locked the bedroom door, went into the bathroom and locked that door and called her friend (no further information) who in turn called our police dispatch.

Meaghan completed a sworn written statement in which she advised that she WOULD testify in court but that she did NOT wish to prosecute criminally; this statement will be submitted with this report. The photographs taken will be electronically submitted into the Boynton Beach Police Evidence Database (A.D. A.M.S.) via the Digital Acquire program. Based on the above facts I find probable cause to charge Brett with Felony Domestic Battery by Strangulation in accordance with F.S.S. 784.0 4 1 ( 2 ) ( a ) as well as Simple Battery (Domestic) in accordance with F.S.S. 784.03 (1) (a) (1).

Meaghan was given a case card, victims rights brochure, a domestic violence pamphlet and signed an exemption from public records form; to be submitted with this report. Brett was placed into handcuffs (double locked and checked for tightness) and transported to the B.B.P.D. for processing. Brett was later complaining of chest pains therefore was transported to Bethesda Medical Hospital for medical clearance in reference to being processed into the Palm Beach County Jail. Once being cleared medically and after being cleared from having any wants or warrants, Bretts's care and custody was turned over to the Palm Beach County Jail. A 911 and Radio Traffic request will be submitted and once obtained will be attached to this case.
