On the 9 day of MARCH 20 18 at 1300 AM PM

On 3-9-18 a lawful search warrant was executed at 5801 Churchill Circle East, WPB, Florida. WPBPD SWAT team made entry and secured Jason Adams, Brett Stancell, and Sara Beachamm. After they were secured and the house was cleared and turned over to us. I walked up and spoke to all three and advised them of their Miranda rights. All understood and Jason advised he was in the front bedroom and Brett and Heather in the rear bedroom. Jason stated he had marijuana and three guns in his room and the marijuana and scale on the dining room table were also his. Brett stated everything illegal in his room was his and not his girlfriends. We then began the search and in the dining room table we found a bong, scale and bag of marijuana. this bag weighed 12 grams. We then searched his bedroom and on the top shelf was a Mossberg shotgun and we were unable to locate the serial number at this time. we then found in a small night stand a Glock handgun model 17 # AZ6613US. In the lower shelf was a heat sealer and heat sealed bags. There was a rifle case in the closet and inside was a Ruger with scope and it was a 22 caliber # 125-06188. On the shelf under the shotgun was a chest. Jason stated his marijuana was inside this chest. In the chest I found 2 packs of Viagra, two white muscle relaxer pills (Carisprodol pills), and multiple containers of marijuana. I placed the marijuana into evidence bags and they weighed, 13 grams, 30 grams, 16 grams, and 61 grams. There was also 2 vials of testosterone. Jason took full responsibility for the marijuana and Pills and testosterone.

In the second bedroom (Brett Stancell) room we found a prescription bottle of marijuana (8 grams) and a bottle of Xanax pills (110 pills 44 grams). There was also 2 hash oil pens (44 grams). Brett took full responsibility for all three of these drugs as his and his alone.

Both men were arrested and transported to PBSO Jail without incident for the drug charges they confessed to Post-Miranda.
