


<p>On 06/08/17 I responded to "B" screening at the Palm Beach International Airport on report of a passenger with bullets. Upon arrival I was advised that there was a gun in the passenger's bag. I then spoke with Transportation Security Officer (TSO) Khamilea Boynes, who advised that she located an anomaly on the X-ray machine of lane #3. A hand search of the bag was conducted. A semi-automatic handgun was located inside the bag. PBSO was notified. I made contact with the passenger, Brian B. Jones, who presented his United States passport to me and a Louisiana driver's license #002908348 as identification. Jones said the handgun belonged to him and that he forgot it was inside his carry on luggage. When I did a search of Jones' bag I located the gun, a Smith & Wesson .40 caliber loaded with nine rounds in its magazine. There was no round in the chamber of the gun. Jones stated he does not have an active concealed weapon or firearms permit, but has applied for one. Due to the above facts, Jones was arrested for carrying a concealed firearm per F.S.S. 790.01 (2). Jones was handcuffed and transported to the Palm Beach County Jail.</p>
