Probable Cause

On December 12, 2019 I was on routine patrol in my marked patrol car in Palm Beach County. I arrived on the scene of a traffic collision that occurred on westbound Okeechobee Blvd (SR-704) and I-95 (SR-9). I observed that there were three vehicles in the roadway with obvious collision damage. I made contact with West Palm Beach PD officer R. George #1973. He stated that he arrived on the scene of the collision and was told by a driver involved that the grey Chevy suv ahead was involved in the collision and tried to flee the scene. He stated that he observed that the Chevy had obvious front end damage and airbags deployed and the driver was still in the driver's seat. I arrived and observed that the driver was in the driver's seat and was the only occupant of the vehicle. I observed that he had bloodshot glassy eyes, slurred speech and the odor of an unknown alcoholic beverage was emitting from his breath as he talked. Officer Y. Abreu arrived on the scene and began the crash investigation. He then informed me that he was complete with the crash investigation. I then spoke to the driver of the grey Chevy and identified myself and later identified him as Brian Vrana by his FL DL. I then read him Miranda Warning from my state issued Miranda warning card. He stated that he understood and that he does not want to do any test and that he wants a lawyer. He refused to conduct field sobriety exercises. As he stood in front of me I observed that he had bloodshot glassy eyes, slurred speech and orbital sway and the odor of an unknown alcoholic beverage was emitting from his breath as he talked. Taylor warnings were then read and he stated that he understood and refused to conduct field sobriety exercises. He was then placed under arrest for DUI and secured inside of my patrol car. He was then transported to the county jail.

Once I arrived at the testing facility I conducted a 20-minute observation of Mr. Vrana. At no time did he regurgitate or take anything by mouth. I then requested that he provide a lawful sample of his breath and he refused. Implied consent was read and he stated that he understood and refused again. He was then booked into the county jail.

The above incident occurred in Palm Beach County.
