

(4/28/80) has recently been suffering from depression, and was drinking alcohol in excess during the day.

J. Adelman stated B. Adelman began to get upset because the Thanksgiving dinner was not prepared on time and they both got into a verbal altercation. J. Adelman admitted to me that she was recently involved in an affair with another man, and stated B. Adelman wanted to use her phone to call the person she had the affair with. J. Adelman further advised while she was in the garage with B. Adelman, he attempted to grab her phone from her hands. J. Adelman stated B. Adelman was initially unable to pry the phone from her hands, and he then grabbed her by both shoulders and attempted to take her to the ground. J. Adelman stated while falling to the ground she grabbed onto B. Adelman's shoulders, and pulled on his shirt to keep herself from hitting the floor.

Officer J. Bernstein provided J. Adelman a domestic violence notice of legal rights and remedies brochure, and I made contact with B. Adelman outside of the residence. I asked B. Adelman basic questions pertaining to the physical altercation, and while doing so I detected the odor of an unknown alcoholic beverage emitting from his person. B. Adelman refused to speak about the incident. Both J. Adelman and B. Adelman declined to fill out witness statements.

I did not take any photographs of either J. Adelman or B. Adelman because there were no apparent injuries.

Officer T. Powell made contact with the neighbor/initial caller W/F Elizabeth Smith (10/28/90) and Smith filled out a witness statement. In Smith's witness statement she stated she heard shouting coming from a garage, and heard a female yell "dont choke me again". Smith also stated she walked by the garage and saw a female up against the wall and a male yelling at her, while kids were yelling "no daddy no". Smith stated she called 911 and then spoke with J. Adelman until the police arrived.


DCF was contacted, due to J. Adelman and B. Adelman's shared children, W/M Jeffrey Adelman (6/8/05), W/F Gabriella Adelman (3/24/07), and W/F Isabella Adelman (9/16/04) witnessing the altercation.

Based on my above described investigation I believe probable cause exists to charge B. Adelman with domestic simple battery in violation of FSS 784.03 (1) (A) (1). To wit: B. Adelman knowingly and intentionally, touched and struck his wife, J. Adelman, against her will. B. Adelman was subsequently transported to Palm Beach County Jail without incident.
