On the <u>25</u> day of <u>May</u> 20<u>19</u> at <u>2331</u> ☐ A.M. ☒ P.M. (Specifically include facts constituting cause for arrest.) On 05/25/2019 at approximately 2332 hours I responded to Pizza hut at 11851 Southern Blvd in reference to a battery that just occurred. While in route PBSO dispatch informed that that the caller stated a white male customer wearing a blue shirt and blue jeans was inside the store and hit an employee with a credit card machine. Upon arrival I observed a white male wearing a blue shirt and blue jeans hiding on the west side of Pizza Hut behind some bushes. The make appeared intoxicated and I placed him in two sets of handcuffs which I checked for proper fit and double locked. I then spoke with Pizza Hut employee Nicholas Armstrong who stated a white male came in to the store and appeared extremely intoxicated. The male began yelling and threatening Nicholas. Nicholas told the male he was not going to be taking any orders from him and he needed to leave. The make became more agitated and started throwing items. The make then threw a credit card machine at Nicholas which hit him in the head. Nicholas stated this was against his will and wanted to prosecute. I walked with Nicholas to the location the make who I later identified as Brian Keith Rauch was being detained and Nicholas positively identified Brian Rauch as the male who battered him. Nicholas completed a sworn written statement. While inside Pizza Hut I observed several papers on the ground. I also saw a credit card machine on the counter that Nicholas stated was thrown and hit him in the head. I then read Brian his rights from a printed PBSO rights card and he told me he wanted a lawyer. Based on my investigation I believe Brian Rauch did actually and intentionally touch or strike Nicholas Armstrong against the will of Nicholas Armstrong {or} did intentionally cause bodily harm to Nicholas Armstrong, contrary to Florida Statute 784.03(1). (1 DEG MISD). I transported Brian to the PBSO District 9 Office where I completed the arrest paperwork. I turned Brian over to D/S Orozco for transport to the county jail.
