Ashley stated that they were arguing over a child custody situation and advised that as she attempted to retrieve her 3 year old son's car seat from the back seat on the passenger side, Brian tried to "slam the truck door on her multiple times". Ashley stated that when she continued to try to open the truck door, he forcefully tried to crush her with the door and aggressively grabbed her shoulders and yanked her backwards throwing her into the neighboring car against her will, causing bodily harm. This occurred in front of the 8 year old daughter, Shelby Kosack, and 3 year old son, Colby Kosack, that Brian and Ashley have in common.

I observed red marks and swelling on both of Ashley's arms. I read Ashley Miranda Rights and she provided a written statement, attesting to these allegations.

Shelby Kosack, Brian and Ashley's daughter, provided a written statement advising that she witnessed her father slamming the door on her mom.

After being read Miranda Rights, Brian provided a written statement attesting that Ashley struck him on the left side of the face with a closed fist against his will, causing bodily harm, and he subsequently restrained her.

It should be noted that Brian stated that although today, Friday, November 22, 2019 is Ashley's day to have the kids, he wanted to take Colby to show him his new daycare. The custody agreement days are clearly stated in the agreement they are both aware of. .

Brian was placed under arrest for domestic battery F.S.S. 784.03 (1A1) and Officer Fisher(School Police #843) transported him to Palm Beach County Jail for processing and booking.
