On 02-10-17 I responded to the Somerset Academy Boca located at 333 SW 4th Ave in reference to a report of child abuse.

Upon arriving at the school I met with BRPD Officer Steven McErlain, Principal Daniel Shourds and Department of Children and Families Investigator Susan Defiglio. Shourds stated that on 02-08-17 he had a meeting with fourth grade teacher Arlene Gebber. Gebber told Shourds that she had concerns about fourth grade teacher Brian Kornbluth. Gebber reported that Kornbluth has been repeatedly requesting that certain male students be scheduled to attend his class. Gebber was concerned that Kornbluth seems to pay special attention to young male students and that his behavior was concerning and suspicious. All of the classrooms at the academy are equipped with video surveillance. On 02-08-17 Shourds waited for a time in which Kornbluth was not in his classroom and re positioned the surveillance camera within the classroom to capture the area surrounding Kornbluth's desk. On 02-09-17 Shourds reviewed the video surveillance. At approximately 7:25am on 02-09-17, prior to Kornbluth leaving for a school field trip, he is observed sitting at his desk reviewing paperwork. Ten year old fifth grade student _____ enters the classroom and engages in conversation with _____. No audio is available. A short time later Kornbluth is captured on video surveillance kissing _____ on the lips one time just prior to _____ leaving the classroom. As this behavior concerned Principal Shourds he contacted Kornbluth and immediately suspended him from working at the school. _____ parents were contacted and later met with Shourds at the school and were informed of the incident. The following morning Shourds reported the incident to the Boca Raton Police Department

<p>and spoke to him. During our conversation [REDACTED] did not disclose that he was kissed by Kornbluth and made no other statements indicating that he had been a victim of any other crime. Due to what was observed on video and [REDACTED] not providing and information about the incident an interview was scheduled for [REDACTED] at the Child Protection Team offices located in West Palm Beach.</p> <p>On 02-13-17 [REDACTED] participated in a forensic interview conducted by CPT Case Coordinator Vanessa O'Steen at the Child Protection Team Office located at 5305 Greenwood Avenue, Suite 101 in West Palm Beach. The interview was video recorded. During the interview [REDACTED] disclosed that Kornbluth had kissed him on the lips several times. while at [REDACTED] did not disclose any other instances of inappropriate contact with Brian Kornbluth.</p> <p>On 02-15-17 [REDACTED] eleven year old sister, [REDACTED] participated in a forensic interview at the Child Protection Team offices in West Palm Beach. The interview was video recorded. In summary, [REDACTED] disclosed that when she was in the fifth grade she went to visit Brian Kornbluth in his classroom at the Somerset Academy with her brother [REDACTED] so that they could get some gummy bears from him. Kornbluth gave both children gummy bears and asked them for a hug and a kiss in return. [REDACTED] stated that Kornbluth kissed her and her brother on the lips one time. [REDACTED] stated that Kornbluth makes her feel uncomfortable and she now avoids contact with him.</p> <p>During the course of this investigation the facts were discussed with [REDACTED] mother [REDACTED] requested that an arrest be made in this case.</p> <p>On 02-16-17 I met with Brian Kornbluth and his attorney Allison Duffie at the Boca Raton Police Department. Kornbluth was advised of his constitutional warnings from a pre-printed card. Kornbluth stated that he understood his rights. After a brief conversation with his attorney Kornbluth agreed to provide a statement. The statement was video recorded. In summary, Kornbluth admitted to kissing [REDACTED] on the lips one time. Kornbluth denied ever kissing [REDACTED]. Refer to the recorded statement for details.</p> <p>Video surveillance recovered from 28 year old teacher Brian Kornbluth's classroom clearly captures Kornbluth kissing 10 year old student [REDACTED] on the lips one time. Follow up investigation revealed that 11 year old student [REDACTED] was also kissed on the lips one time by Kornbluth in his classroom after Kornbluth gave her some gummy bears. Brain Louis Kornbluth, D.O.B 05-23-1988, is charged with two counts of simple battery.</p>
