On 7/17/2017 at 1750hrs I responded to the Boca Palms neighborhood located at 22017 PALMS WAY in unincorporated Boca Raton, FL 33433 in reference to a man down incident. Upon arrival I met with Heather Hunteman who told me she was passing by and observed a white male with a beard lying on the ground in the parking lot near the front exit. The unknown male appeared to be intoxicated and but conscious and breathing. I also made contact with George Huber who lives in the neighborhood as the HOA president and he told me that he has received several phone calls from other residents about a unknown white urinating in the grass area near the east side of the pool area.

While on scene I observed a white male later identified by FL DL, as Brain Husk sitting on the side walk near building 22052 unit#106. Brian appeared to be intoxicated and he was slurring his speech. While speaking with Brian he was disoriented and I could smell alcohol emitting from his mouth area. He was unable to articulate his reason for being in the area and he also stated he does not live in the neighborhood and he was trying to take a nap. Brian was also not cooperative with my investigation and was belligerent yelling "Fuck YOU leave me alone!" Palm Beach County Fire Rescue (run#17077051) was called to the scene to treat Brian for a medical evaluation.

At that point, I told Brian he was not free to leave the area and he pulled his arm away from my grasp and attempting to run away while I was conducting an outer pat search for officer safety. Brian used his hands to avoid from being restrained and lost his balance and fell to the ground. He refused to obey several verbal commands to stop resisting. While on the ground I was able to gain control of Brain's hands and secure handcuffs and double lock. He was then transported to West Boca Medical Hospital for further medical evaluation and continued to be belligerent and not cooperate with Fire Rescue staff and myself.

Based on my investigation and the statements provide by all parties involved I found probable cause exist to charge Brian Husk is in violation of F.S.S 843.02 Resisting w/o violence. After being medically cleared from the hospital he was later transported to Palm Beach County Jail for further processing.
