On February 9th, 2019 at approximately 1801 hours, I responded to Target located at 650 North Congress Avenue Boynton Beach, Florida 33435 in reference to a retail theft.


Upon arrival, I made contact with Target Loss Prevention Officer Bryan Vargas. Vargas advised in a recorded sworn statement that while on direct floor observation and surveillance he observed a white male later identified as Brian Rubin placing several domestic items in his shopping cart and while at self check out, he would pretended to scan items and then place them in his shopping cart without paying for them. Vargas advised Rubin would scan lower ticket items then place higher ticket items in his cart in shopping bags without paying for them. Rubin then proceeded past all points of sale and exit the store, failing to render payment for the concealed items. LPO Vargas approached Rubin outside of the store, detained him and escorted him back to the loss prevention office where the merchandise was recovered. Vargas provided an itemized receipt and the subtotal of the items was \$453.20. Vargas advised that Target would prosecute Rubin.


Based on the aforementioned, Brian Nathaniel Rubin was detained (double locked, checked for tightness) and placed under arrest for Retail Grand Theft pursuant to F.S.S 812.015.8. Rubin was trespassed warned in my presence by Vargas forbidding him from entering Target for a period of one year from the date of this report. Rubin acknowledged the trespass agreement.

An NCIC/FCIC query was conducted for Rubin and he was negative for wants and warrants.

Itemized Target receipt were submitted via transmittal. Vargas' sworn statement was captured on my department issued body camera. Target surveillance video entered into BBPD Evidence. This incident was captured on my department issued body camera.
