





The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. The Person taken into custody... [checked] was found to have committed the below acts, resulting from my (described) investigation.

On 06/21/17, I was assigned a fraud case for follow-up investigation. The initial report was taken by Officer Michel on 05/19/17. I reviewed Officer Michel's incident report and learned that Terry O'Connor reported that several months ago she met a psychic named Kyra Chase (305-965-1350) who was representing Master Love Psychic. During the course of several months, Chase convinced O'Connor to turn over her money and jewelry so she could cleanse it from the evil spirits attached to it. Chase promised to return the money once the spiritual work was done. O'Connor whole heartedly believed her and eventually gave her roughly \$90,000.00 in cash and another \$90,000.00 in jewelry. On 06/27/17, I met with Terry O'Connor at Boca Raton Police Department and she confirmed the above information. We conducted a controlled phone call with Kyra Chase at 305-965-1350. The recording was placed into evidence at Boca Raton Police Department. In the recording O'Connor confronts Chase about wanting her money and jewelry returned to her. Chase dodged the questions and stated that they first needed to finish the spiritual work. O'Connor mentioned the contract that they signed and Chase stated that she never wanted to put a date on the contract. Chase never denied that she had the money or jewelry and said she would call her back to figure out a solution since she promised the angels the rest of what they needed to finish (additional money.) Through investigative research I was able to discover that Kyra Chase's real name and identity is Bridgette Evans (DOB: 09/06/1978). On 07/13/17, Detective Leonard showed Terry O'Connor a photo lineup. O'Connor positively identified Bridgette Evans as Kyra Chase in position number 6. See his supplement for further details. After the photo lineup I obtained a taped audio recorded statement from Terry O'Connor.

<p>O'Connor stated that on March 21, 2017 she was feeling depressed because her son had moved out. O'Connor called her friend Nicole Quintavale and asked her if she knew anyone that could clear energy. Quintavale referred her to Kyra Chase and said she was the real deal. O'Connor called Chase and explained what she was going through. Chase said she would meditate on it but that they needed to meet right away. The next day they met at O'Connor's home. Chase told her that she meditated last night and discovered that there was a curse on her family from a past life and bad things would happen to her. O'Connor would get her father's cancer and her daughter would become addicted to heroin. She offered to work with O'Connor to clear the energy. She stated she could feel the evil energy in her home and the "dark cloud". Chase stated she would work with nine angels to clear the energy. Chase further explained to O'Connor that the root of the evil is negativity in her finances/money. According to Chase, 75-80% of her finances was negative energy and needed to be cleared. She later changed it to 90%. Chase stated that the angels were sensing the dark cloud and it would require a lot of work to clear it. She also told O'Connor that any jewelry she received from her ex-husband was tied to the bad energy and she needed to put the jewelry in a bag under her pillow and Chase would try to clear it from afar. She then proceeded to tell O'Connor about a soul mate that she would meet but not until the cloud was clear. If O'Connor agreed to work with Chase she would clear the cloud and there would be no cancer, no addiction and she would be able to meet her soul mate.</p> <p>Over time, Chase and O'Connor communicated over the telephone, through text messages and in person. O'Connor recalls randomly running into Chase at the oddest locations. Chase told O'Connor that in order to clear the cloud (curse) O'Connor needed to take the money out of her IRA account and put it in a box, which represents a coffin. O'Connor took \$50,000 out of her account and put it in a shoebox along with her jewelry and a written prayer as she was instructed to do by Chase. A few days later Chase informed O'Connor that it didn't work and she needed to see the box and pray on it in person. Around April 4th, Chase went to O'Connor's home (455 Mohawk Lane, Boca Raton) and requested that O'Connor get another box, a bag and tape. She proceeded to tape the box in order to suffocate the energy. Chase told O'Connor that the energy was so strong it was burning her. She then proceeded to talk to the angels, got up and left the house with the box before O'Connor could stop her. O'Connor immediately texted Chase who told her that she could not cleanse it at her home so she needed to take it to the altar at her home. Chase told O'Connor that by next Wednesday she would have the money back in her account. The box contained \$50,000 cash, an engagement ring valued at \$75,000, a wedding band valued at \$11,280 and a Rolex watch valued \$5,200. The appraisal paperwork was submitted into evidence at Boca Raton Police Department.</p> <p>A few days later Chase tells O'Connor that the angels said they needed more money to clear the cloud. It must be done because the universe can't be tricked. Those were the instructions she got from the Angels if she wants to clear the cloud. O'Connor conceded and took an additional \$7,000 out of her account. She was instructed to put it in a</p>

That afternoon, Chase appeared at her house stating that she needed to put the \$7,000 with the rest of her money. At this point, O'Connor started to become concern about her money and asked Chase to sign a contract. Chase signed the contract and showed O'Connor her identification which she thinks was in the name of either Kyra Chase or Kara Chase with an address in Boca Raton. At this point, O'Connor continues to communicate with Chase and finds out that Chase's boyfriend's name is Vinnie Uwanawich. Chase also sends O'Connor to different locations where she will meet her soul mate named Gabriel. It should be noted that the Uwanawich family is known to the Boca Raton Police Department as a gypsie family.</p> <p>Around April 19, Chase instructs O'Connor to give her an additional \$33,000 in cash in order to finish clearing the cloud. She stated she needed three parts to clear the three evil energies. Chase instructed O'Connor to go to three different banks to take out three different amounts. O'Connor was skeptical about giving her the money but eventually gave in when Chase showed up at her home around 9pm. She realized that Chase was not going to leave without the money so she gave it to her with the agreement that she would return it as soon as the cloud was cleared. The additional \$33k was added to the contract with a return date of May 2. Chase proceeded to tell O'Connor she would have three big real estate sales. Shortly after she gets a phone call from "Toni" stating he wanted to buy a house for \$995,000 in Hidden Valley. O'Connor makes an appointment to show Toni the house. Prior to meeting at the house, Toni sends a text to cancel because his father-in-law fell ill. O'Connor text back and forth with Toni and he agrees to buy the home for \$979,000 he then tells her that he has a friend named "Gabe" that he wants to introduce her to. She asked Toni for a picture of Gabe and she received one from Chase which she found to be suspicious. Toni told O'Connor that he was going to inherit money from his father-in-law and wanted to buy two additional properties. O'Connor sets up appointments to see two additional properties but Toni never follows through. According to Chase, O'Connor was rude to Toni about the properties and Toni blocked her number. O'Connor never met Toni and doesn't believe he exists. She believes that Chase was behind the entire thing. The number O'Connor communicated with Toni has since been disconnected.</p> <p>Around April 20th, O'Connor asked her daughter to cooperate with Chase because Chase told her that her daughter, Kelly was the reason she wasn't able to clear the cloud. O'Connor further explained to Kelly that Chase had her life savings and her jewelry. O'Connor was not supposed to tell anyone because she was sworn to secrecy by Chase.</p> <p>Kelly decided to tell O'Connor's son, Sean what was going on between O'Connor and Chase. Sean instructed his mother to call the police because she was being scammed. O'Connor stated that she has asked Chase to return the money and jewelry numerous times and Chase always says she will when she is done. O'Connor then told her that she was no longer interested in clearing the cloud and just wanted her money and jewelry returned. O'Connor has offered to retrieve the money but Chase has not agreed to it.</p>

<p>O'Connor stated that she believes the person in position number 6 of the lineup is the person she knows as Kyra Chase. She originally said that she was 95% positive it was Chase because the hair was different and she never saw Chase with earrings. She then stated that looking at the lineup again she is 100% positive that it is Kyra Chase. It should be noted that the person in position number 6 is Bridgette Evans, DOB: 09/06/78. The photo lineup and recorded statement were submitted into evidence at BRPD.</p> <p>On 07/21/17, Terry O'Connor signed a consent to search card to have the text messages from her Apple I-Phone imaged. Detective Turek copied the text contents between phone numbers 561-945-0909 and 305-965-1350. The consent form and printed extraction report with the text messages were submitted into evidence at Boca Raton Police Department. The text messages support O'Connor's account of the events. The text messages document O'Connor asking for her money back numerous times, Chase admitted that she has the money and also requesting additional money. Also, in the text messages Chase ask O'Connor if she has a target card because she knows how to turn it into cash.</p> <p>On 07/28/17, I sent a subpoena request to At&amp;t for Bridgette Evans phone number.</p> <p>On 09/20/17, I received the At&amp;t subpoena documents showing that phone number 305-965-1350 is registered to Vinnie Uwanawich at 19940 W Dixie Hwy, Apt 13103, Miami, FL since 02/25/2016.</p> <p>On 10/10/17, Boca Raton Police Department received another complaint (BRPD case 17-013944) against Bridgette Evans. The victim, Hannah Wickins, reported that she purchased a Groupon for Psychic that Loves You in hopes to become spiritually cleansed. Wickins opened up to Chase and Chase eventually convinced her that the \$400,000 she had in the bank needed to be cleansed. Wickins took out \$400,000 in cash and placed it in shoe boxes as instructed by Chase. Chase then told Wickins to come to her home (313 E Palmetto Park Road, #618). Wickins did not feel comfortable driving around with so much money so she invited Chase to her home. Wickins stated that Chase was in her home for 3-4 hours then took the money and tried to leave with it stating that she needed to take it to finish the cleansing. Wickins told Chase she was not comfortable with her taking her money and prevented her from leaving with it. Wickins was able to deposit the money back into her account. Afterwards, Chase continuously texted Wickins stating that evil things would happen to her if she didn't finish the cleaning process and the angels would put a curse on her. Wickins explained to her boyfriend what had happen and he convinced her to speak to the police because he believed she was not a legitimate psychic. Wickins further explained that a similar incident happened to her friend who also did not let Chase leave with her money.</p> <p>On 11/14/17, another victim reported to the Boca Raton Police Department that Kyra Chase aka Bridgette Evans defrauded her out of \$220,000. According to the victim, Chase told</p>
