D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 30TH DAY OF June 20 17, AT 2324 AM PM
SUSPECT: Bridgette Rossel CASE NUMBER: 17-003216

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
I was traveling west on West Indiantown Road when I observed a 2007 black Ford bearing Virginia License Plate DCTEMZ traveling directly in front of me in the left hand through lane. As the vehicle approached Pennock Drive, it swerved to its right and drove on top of the lane markings before returning to its lane. There was a car next to it that did not react. The vehicle then began to travel close to the car in front of it and nearly struck the median on its left, crossing over the solid yellow fog line separating the curb from the roadway. I then decided to initiate a traffic stop. The vehicle stopped at the red light for Delaware Boulevard while I was waiting for the tag information to come back and stopped over the marked cross bar and on top of the marked crosswalk. As the vehicle turned south on South Delaware Boulevard, it again nearly struck the curb and after I initiated a traffic stop of the vehicle it struck the curb on the right hand side of the roadway. I made contact with the driver and sole occupant, Bridgette Rossel.

OBSERVATION OF DRIVER:

I immediately noticed that Rossel's eyes were glassy. Rossel was wearing only a bra and no other clothes. Rossel stated she had to go to the bathroom and had taken her clothes off. Rossel had difficulty focusing and forgot what documents I was asking for. I had Rossel put her clothes on.

DRIVER'S STATEMENTS:

Rossel initially stated that she'd consumed two glasses of wine. Rossel later stated that she had three drinks but was evasive when I asked what she had exactly.

ODORS:

Odor of unknown alcoholic beverage on breath.

GENERAL OBSERVATIONS

SPEECH: Slurred, thick tongued

ATTITUDE: Cooperative, mood swings, laughing, joking

CLOTHING: Pink sweater, blue jeans, white flip flops

Other Observations:

Angle of onset observed at approximately 30 degrees. Unable to observe VGN as Rossel kept burying her head in her hands and was unable to focus.

WALK & TURN

Had difficulty maintaining starting position. Rossel missed heel to toe on every step and stopped between every step on the first nine. Rossel also used her arms for balance on the third step. On the ninth step, Rossel bent over and picked a card off the ground. She then continued to walk along the line, taking a total of 13 steps. Rossel stopped at her car's trunk and examined the card. I told Rossel it was vital that she concentrate on the task. Rossel turned around (improperly), and balanced with her right hand on the hood of her car. Rossel then returned 16 steps, missing heel to toe on every step again and taking approximately normal length steps.

ONE LEG STAND:

Rossel stated, "I can't even do that sober" when I asked her if she had any questions about the task. Rossel did not count out loud. About six seconds after starting, Rossel hopped, used her arms for balance, and then placed her foot down. Rossel raised her foot again and put her hands on her hips. About 21 seconds after starting, Rossel placed her foot down again.

FINGER TO NOSE:

L1: Rossel touched the tip of her nose with the pad of her finger and forgot to put her finger back down to the side. R2: Rossel touched over the her left nostril with the pad of her finger and forgot to put it back down again. L3: Rossel touched the tip of her nose with the pad of her finger, forgot to put it back down to side again. R4: Rossel touched the tip of her nose with the pad of her finger. R5: Rossel touched the pad of her finger to the tip of her nose and opened her eyes. I reminded her to close her eyes. L6: Rossel touched tip of nose with the pad of her finger. Rossel was swaying visibly during the task.

ROMBERG ALPHABET:

Stated the Alphabet as follows: A B C D E F G H I J K L M N O (then opened eyes) P Q R S T U V W U R S then said, "I had to give my dog away".

Romberg Balance: Rossel estimated the passage of 30 seconds in 43 and was swaying visibly. Rossel opened her eyes during the task.
