
On June 6, 2016 at approximately 1305 hours I was dispatched to 10790 Haydn DR, in unincorporated Boca Raton FL 33498, in reference to taking Brittany Prisco into custody for a warrant that she had for Mental Health Contempt (WARR# = 16 000525 MHSB DIV). Sal Prisco called 911 and stated that his daughter had a warrant and he wanted the Sheriff's Office to take her into custody. Upon arrival a white male was in the garage and he went inside to get Judeann Prisco. Judeann voluntary let me and Deputy Udell inside the residence and she stated her daughter was upstairs in her bed room. I made contact with Brittany inside her bedroom and I stated to her that she was coming with me due to her having a warrant reference to a mental warrant and needed to go to the county jail and be evaluated. I placed her in handcuffs, double locked, checked for tightness and proper fitting. As I was now escorting her downstairs she started to get agitated and started to ask where's the warrant show me the warrant. As her mother started to grab some of her jewelry off of her she started to yell and pull away from myself while she was in handcuffs. I then had to forcefully escort her out of the house to my patrol car as she was trying to pull away from me. As myself and Deputy Udell tried to place Prisco into the rear seat of the patrol car she actively resisted by kicking myself in the chest area and upper leg area. She also kicked Deputy Udell in the upper leg area. Deputy Udell then approached the rear driver side door to gaining control of her as I was attempting to secure her in the patrol car from the passenger side. Prisco was now attempting to exit the vehicle through the rear driver side door. I then assisted Deputy Udell with placing her into the vehicle from the driver rear door. At this point Prisco kicked me in the face as she was attempting to get of the patrol car. AT this time she was still combative by repeatedly kicking and screaming at me and Deputy Udell. At one point Deputy Udell tried to mobilize hobble Prisco's legs so deputies would not get kicked any further. Attempts to hobble her were unsuccessful because she continued to kick at myself and Deputy Udell. She verbally told to stop resisting our efforts to secure her and at one point as we tried to hobble her I asked her to give me her leg so I could secure her leg in the hobble in which she stated no. One leg was under control of the hobble while the other leg was free to strike. She was still non-compliant with our efforts to secure her in the patrol car.

Due to her noncompliance we were outside the patrol car in the road way and she was told to sit down in which she did not comply. Deputy Udell had her right leg secured with the hobble. I then swept her left leg and she was assisted to the ground. At this point she was under our control yet still not in the hobble. As Deputy Udell tried to secure both legs into the hobble I held Priscos hair due to prevent her from possibly biting deputy Udell. At this point deputy Udell requested more deputies to the scene to assist in gaining control of Prisco. This was done to prevent Prisco from sustaining any injuries that may occur while attempting to gain control of her. Deputies responded and while gaining control of her she freed herself from the handcuffs in which she was placed back into them and was able to place her into the patrol car. I then transported her to West Boca Medical center for further evaluation. I then transported her to the Palm Beach County Jail without incident. Let it be noted I and Deputy Udell were wearing Palm Beach County Sheriffs class B uniforms identifying us as Palm Beach County Sheriffs Deputies and driving marked Palm Beach County patrol cars.

Due to the above facts and circumstances Brittany Prisco is being charged with one count of fail to appear for her warrant, one count of resist with violence and 2 counts of battery on a law enforcement officer on myself and Deputy Udell.
