

I responded to [REDACTED] in reference to a domestic dispute.

While enroute dispatch advised that a male and female were engaged in a verbal altercation and that the male [REDACTED] was breaking items within the above listed apartment. The complainant advised that she could hear the disturbance through the walls of her apartment. Dispatch further advised that the male was loading items into a black Nissan Altima in the parking lot of the above listed location.

A short time later D/S Rodriguez (13919) and I arrived on scene and located a black Nissan Altima which was occupied by a B/M later identified as [REDACTED]. Given the allegations above [REDACTED] was temporarily detained in handcuffs while Deputies conducted an investigation as to what occurred. While on scene I spoke with [REDACTED] while D/S Rodriguez made contact with [REDACTED] Brittany Hewity. During my contact with [REDACTED] I noticed that he had a superficial cut to the left side of his jaw. [REDACTED] on his own accounts advised to me that his [REDACTED] threw a bottle of hair gel at his face causing the small laceration to his face. [REDACTED] went to state that he and Hewity got into a verbal altercation over infidelity in [REDACTED].

While speaking with [REDACTED] I could see in the distance that D/S Rodriguez was gathering information from Hewity. Once D/S Rodriguez was finished speaking with Hewity she walked over to me after several times of me telling to her to stay on the sidewalk so that a further altercation would not ensue between [REDACTED] and her, however she continued walking towards [REDACTED] and I. From there Hewity began to spontaneously utter "I threw a bottle at him I should be going to jail not him."

A short time later D/S Rodriguez approached and advised me that during his contact with Hewity, she told him that she threw a bottle of hair gel at him because she believed that he was [REDACTED] on her. Being that both parties' statements, and utterances were consistent, I requested that [REDACTED] provide me with a sworn written statement of what occurred, however he denied to do so.

It was later learned that the complainant was Hewity's friend Deisi Cuevas who was inside the above listed apartment at the time of the altercation. Deisi stated that she was only inside the living room when the argument began and that [REDACTED] and Hewity were inside their bedroom. Deisi further advised to D/S Rodriguez that she only wanted to give the information and not complete a sworn written statement as to what she observed.

Based on the above set of facts, I find probable cause exists to arrest and charge Brittany Hewity with (1) Count of Domestic Battery pursuant to F.S.S 784.03(1)(a)(1). Hewity was processed in the parking lot of 6049 S Military Trail and later transported to the Palm Beach County Jail.
