	<p>On Tuesday, 8-23-16, at 0301 hours I responded to 235 Courtney Lakes Cir, Apt 106, in reference to harrassing calls.</p> <p>Upon my arrival I spoke with Brittney Pieplow, who appeared to be extremely intoxicated as her speech was slurred, the smell of alcohol was emitting from her person and she was unable to keep her balance, who stated she was receiving harrassing texts from "Jennifer."</p> <p>Ofc Streigold and I read the text messages and they spoke about drinking, sex, beauty queens and whether she left her phone at "Jennifer`s" house. None of which were threats. Pieplow then stated "Jennifer" was knocking at her door at odd times. We asked Pieplow when did this happen and she stated the night before. We advised Pieplow that there was no crime done and we could not do anything. At which time she walked towards "Jennifer`s" apartment.</p> <p>WPBPD received another 911 call from Pieplow in reference to "Jennifer" stalking her. I spoke to Pieplow and she stated "Jennifer" was stalking her because she keeps knocking at her door. No one was present but Pieplow. I asked her why she walked to "Jennifer`s" apartment as we left the first time and she stayed quiet. I told Pieplow there was no crime and she was advised that falsely calling 911 can result in her arrest.</p> <p>Before we could left the premises, dispatch received 4 more 911 calls from Pieplow. Two 911 calls were hang-ups and the two other 911 calls were to request an officer respond back. It should be noted that each time Pieplow called 911; WPBPD communications gave her the non-emergency line.</p> <p>Based on the aforementioned facts Pieplow did unlawfully and knowingly access the number 911 for the purpose of making a false alarm or complaint or reporting false information</p>
