As I approached the drivers window I observed a white female, later identified as Brittney Lartitegui, wearing a black tank top and black shorts. I told Brittney the reason for pulling her over and asked for her drivers license. Brittney pulled out a visa bank card. I explained to her that this was not her drivers license and she then provided me with it. I then asked Brittney to turn off her vehicle to which she complied. I asked her to give me her keys and she then handed me a lighter. I explained to her that what she tried to hand me was her lighter and not her keys. Brittney then proceeded to start her vehicle. I told her not to turn her car off and leave it off. Brittney, turned the vehicle on three more times. I began to ask Brittney simple questions to which she would not answer. I then had Brittney exit the vehicle to prevent her from starting the vehicle. While out of the vehicle, Brittney tried to get back into the vehicle. She was told multiple times to stay out of the vehicle but refused to follow directions.


D/S Gonzalez #18414 arrived on scene and the remainder of this investigation was turned over to him.

On October 14, 2017 at approximately 2341 hours I was responded to 12790 Forest Hill Blvd in the Village of Wellington in reference to a possible drunk driver. Upon my arrival, I made contact with D/S A. Foster #12413 who stated the following. "On October 14, 2017 at approximately 2341 hours I was patrolling the area of Forest Hill Blvd and Wellington Trace when I observed a blue Dodge SUV, bearing Florida tag HVUW89, was in the left turn lane of Forest Hill Blvd and Wellington Trace in the intersection. The vehicle then proceeded to make a left turn from Forest Hill Blvd onto Wellington Trace running a red light. I then activated my emergency overhead lights to conduct a lawful traffic stop. The vehicle then made a right turn into the plaza located on the south east corner. I exited my vehicle and made my approach on the driver side of the vehicle, the vehicle was put in reverse. I then told the driver to put the vehicle in park to which they complied. As I approached the driver's window I observed a white female, later identified as Brittny Lartitegui, wearing a black tank top and black shorts. I told Brittny the reason for pulling her over and asked for her driver's license. Brittny pulled out a visa bank card. I explained to her that this was not her driver's license and she then provided me with it. I then asked Brittny to turn off her vehicle to which she complied. I asked her to give me her keys and she then handed me a lighter. I explained to her that what she tried to hand me was her lighter and not her keys. Brittny then proceeded to start her vehicle. I told her not to turn her car off and leave it off. Brittny, turned the vehicle on three more times. I began to ask Brittny simple questions to which she would not answer. I then had Brittny exit the vehicle to prevent her from starting the vehicle. While out of the vehicle, Brittny tried to get back into the vehicle. She was told multiple times to stay out of the vehicle but refused to follow directions. D/S Gonzalez #18414 arrived on scene and the remainder of this investigation was turned over to him."

OBSERVATION OF DRIVER:

I made contact with the def who was standing on the driver side of the vehicle. The def was the sole occupant of the vehicle. I immediately noticed that the def had a strong odor of an unk alcoholic beverage coming from her person. I noticed the def appeared to be swaying as well, and attempting to use the vehicle as a means to steady herself. When having the driver move to the location which I would conduct the SFSTs, she repeatedly stumble.

DRIVER'S STATEMENTS:

I asked the def where she was coming from and she stated from the Pirates Well off Crestwood. I asked her where she was going and she stated to her house. I asked the def if she had anything to drink today and she stated yes. I asked how much she had to drink a captain and coke. I explained to the def that I was conducting a DUI investigation and requested her to do SFST's and she stated sure. I noticed that the def had slurred speech and was moving around a lot. The def stated that she had no injuries or problems. The def was having problems following directions, and was unable to maintain balance. Throughout speaking to the def repeatedly would stumble on her words, and had slurred speech. Upon searching the vehicle incident to arrest, I discovered three small red bags containing an unknown green leafy substance inside of her purse along with two glass pipes which contained an unknown burnt residue.

ODORS:

Strong odor of an unk alcoholic beverage coming from her person. After placing the def in the back seat of my patrol car for several minutes, the vehicle began to reek of an unk alcoholic beverage.


