PROBABLE CAUSE

On April 22ND , 2017 I Trooper Lucas M. Tavares (3913/1555) with the Florida Highway Patrol was on active patrol in Palm Beach County, Florida. I was in a marked FHP unit equipped with overhead emergency lights and external siren. At approximately 10:40 p.m. I was traveling southbound on Interstate 95 (State Road 9) just south of 45th Street. I observed a marked Palm Beach County Sheriff Unit with its lights activated on the right shoulder. The marked unit had a white in color 4-door passenger vehicle stopped. The vehicle was a 2009 white Toyota Camry with the Florida Tag of (742MVL). The deputy was Sgt. A Avey (9347) with the Palm Beach County Sheriffs Office. I then stopped out with the Deputy to render back up. On scene Sgt. Avey (9347) stated to me that he stopped the vehicle for speed and failure to maintain a single lane. He stated when he made contact it appeared that the driver was under the influence of alcoholic substance. He stated that she had slurred speech and there was an odor of an unknown alcoholic beverage coming from within the vehicle. He stated he asked the driver if she had anything to drink and she stated no. He then asked again and she stated to him one glass of wine. He stated to me that he was completed with his traffic stop and I can initiate my DUI investigation.

I then made contact with the driver who I later identified her by her FL DL (R326073906770) as Brittney Marie Rodgers DOB: 5-17-1990. I asked her where she was coming from and she stated Stuart. I asked her if she had anything to drink and she stated yes one glass of wine with a client. While talking to Ms. Rodgers I observed her eyes to be bloodshot and watery, her speech was slurred, and there was a strong odor of an unknown alcoholic beverage coming from within the vehicle. I then asked Ms. Rodgers to step outside her vehicle to the rear. I asked again where she was coming from and she stated Stuart. I asked her again if it was only one glass of wine she had and she stated yes. There was a strong odor of an unknown alcoholic beverage on Ms. Rodgers breath that grew stronger as she spoke.

I then asked Ms. Rodgers if she would perform voluntary field sobriety exercises, she stated yes.

Standardized Field Sobriety Exercises (SFSE):

The area for the following roadside exercises was level hard surface and was free of debris. The weather was clear.

Horizontal Gaze Nystagmus:

I advised the subject to stand straight with their feet together and arms down by their side. I asked subject if she had any medical problems with her eyes that is not corrected by her glasses, she stated no. I had the subject remove her glasses for the exercise. For the exercise I used my issued red stylus and illuminated it with a Streamlight white in color flash light. I asked the subject if they could see my red stylus, they stated yes. The subject was asked about any current medical conditions, they stated that they did not have any. I advised the subject to follow my red stylus with their eyes and eyes only, and to not move their head. I asked subject if they understood the instructions I gave to them. They stated yes. I asked if they had any questions they stated no.

The following was observed during Horizontal Gaze Nystagmus:

- RT EYE-LACK OF SMOOTH PURSUIT
- LT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. DEVIATION

I had to instruct subject again to keep her head straight and follow my stylus with her eyes only. Subject was swaying during the exercise.

The following was observed during Vertical Gaze Nystagmus:

Subject did not have vertical gaze nystagmus.

Walk and Turn Exercise:

Interaction Phase:

The area for the following roadside exercises was level and free of debris. Subject agreed to use an imaginary straight line to perform the walk and turn. I advised the subject to place their left foot on the imaginary line and their right foot directly in front of it, touching heel to toe. I advised the subject to keep their arms down by their side and to stay in that position until I advise them to begin the exercise. This exercise was first explained to the subject then was demonstrated by myself. Subject advised that they would be able to perform the exercise. Subject advised that they had no injuries that would affect the exercise. Subject advised me that they understood instructions and did not have any questions.

- The following was observed during the instructional phase of the exercise:

The subject stepped out of the starting position.

- The following was observed during the walking phase of the exercise:
 The subject missed heel to toe on multiple steps. The subject did not count out loud as instructed. The subject was swaying throughout the exercise. Subject used arms for balance (raised above 6-inches)
 The subject missed heel to toe on multiple steps. The subject performed an improper turn (not as instructed). Subject stopped after the turn. I had to repeat the instructions multiple times to the subject.

One Leg Stand Exercise:

I instructed the subject to stand with their feet together and keep their arms down by his side. I instructed the subject to stay in that position until I tell them to start the exercise. This exercise was first explained to the subject then was demonstrated by myself. Subject advised that they will be able to perform the exercise. Subject advised me that they had no injuries that would affect the exercise. Subject advised that they understood instructions and did not have any questions.

The subject lost balance. The subject put her foot down, and the subject was swaying during the exercise. The subject did not count as instructed.

Based on the totality of circumstances, Ms. Rodgers was placed under arrest for DUI pursuant to Florida Statute 316.193.1 at 10:53 PM. Ms. Rodgers was then placed in my patrol vehicle and transported to the Palm Beach County Jail in which she arrived at 11:11 PM. After the defendant's 20min observation, the defendant was then given the opportunity to provide a sample of her breath which she consented to provided. The defendant's first breath was given at 11:48 PM and resulted in a 0.189. The defendant's second breath was given at 11:51 PM and resulted in a 0.187.

Ms. Rodgers was also issued a uniform traffic citation for the unlawful speed by Sgt. Avey (PBSO 9347). Video of the traffic stop, roadsides and transport are available through the FHP custodian. The above incident did occur in Palm Beach County, Florida.







(Specifically include facts constituting cause for arrest.)</p> <p>On Saturday, April 22, 2017 at approximately 2230 hours, I was traveling southbound on Interstate 95 approaching 45th Street located within the city limits of West Palm Beach, Palm Beach County, Florida. I was traveling approximately 60-65 miles per hour in the lane directly to the left of the far outside lane. A white Toyota Camry (Florida license plate 742MVL attached) traveling southbound in the number one lane passed me at approximately 90 miles per hour or faster. I was driving a marked Palm Beach County Sheriff's Office (PBSO) patrol vehicle (vehicle identification number 1FAHP2M85DG150747) which had been calibrated on 03/09/2017. I am also a certified radar and laser operator in the State of Florida. To obtain the aforementioned certification, one must demonstrate proficiency in visually estimating speeds. I have conducted hundreds of traffic stops for unlawful speed in my law enforcement career where I have had to visually estimate speeds.</p> <p>After passing me, I kept a constant visual on the Toyota as it changed several lanes and ended up in the far right lane. The Toyota decreased its speed once in the far right lane. I activated my overhead red and blue lights and attempted to catch up to the Toyota. While doing so, I saw the Toyota cross over the solid white line dividing the outside lane from the paved shoulder and then maneuver back into the outside lane. The driver (later identified by Florida driver license as Brittney Rodgers) maneuvered the vehicle onto the shoulder without issue.</p> <p>When the Toyota stopped, I conducted a passenger side approach where I saw that Brittney was the driver and sole occupant. I introduced myself and asked Brittney why she was traveling over 90 miles per hour (my visual estimation). I asked Brittney if she had her license, registration, and proof of insurance with her. As I stood at the window, I could smell the faint odor of an unknown alcoholic beverage coming from inside the vehicle. Brittney's eyes were glassy and she had a dazed and confused look on her face. I asked Brittney where she was coming from and she said "Stuart" with a slur in her speech. When I asked Brittney where she was in Stuart, she said "I work at a salon" with a slight slur. Meanwhile, Brittney was making slow and deliberate movements while she provided me with her documents, at one point staring at them as if she were confused. Brittney provided me with her license, registration, and a business card for her place of employment (not something I asked for). I had to remind Brittney that I needed her insurance card and not one for her job. After Brittney provided me with her documents, I asked her how much she had to drink that night. Brittney denied that she had been drinking. Being that Brittney presented several indicators of impairment, I believed that she was being untruthful with me. I asked Brittney a second time how much she had to drink at which time she told me that she had a glass of wine with a client.</p> <p>While I was on the traffic stop, Trooper Tavares #3913 of the Florida Highway Patrol arrived on scene. Based upon the unlawful speed, driving pattern, statements that Brittney made, and the several indicators of impairment that I observed, I provided Trooper Tavares with a brief summary of why I conducted the traffic stop and that I could tell Brittney had been drinking. It should be noted that although Brittney performed standardized field sobriety tasks, I did not watch the tasks in their entirety. I have been through the Standardized Field Sobriety Testing course along with the Advanced Roadside Impaired Driving Enforcement course. I have conducted approximately 40 to 50 documented DUI investigations in my career and have conducted numerous DUI investigations that did not result in arrest. The violation, traffic stop, and roadside contact was captured on audio and video via the in-car camera system installed in my marked PBSO patrol vehicle.</p> <p>This concludes my involvement in this case. Nothing further.</p>




