


On Thursday, November 22nd, 2018, at approximately 0850 hours, I was dispatched to 12061 Tangerine Boulevard, West Palm Beach, in the unincorporated area of Palm Beach County, Florida 33412, in reference to a delayed domestic battery incident.

Upon arrival, I met with the victim, identified by his Florida license as Mr. James Czipulis who explained the following:  
On Wednesday, November 21st, 2018, at approximately 0850 hours, his ex-girlfriend, he identified as being Brooke Taylor (DOB: 11/13/1978) arrived to his residence to pick up their son, Levi Czipulis (DOB: 07/29/2014). Mr. Czipulis asked Ms. Taylor to remain at her vehicle while he prepared their son for the exchange, but Ms. Taylor did not comply. At one point Ms. Taylor had a shoe in her right hand, which she used to strike Mr. Czipulis above his left elbow.

During my investigation, I found that Ms. Taylor and Mr. Czipulis resided together in the past as a family, and they have one child in common. Mr. Czipulis stated he waited approximately 24 hours to report this incident because it put him and Ms. Veloz(the victim's girlfriend) behind schedule to travel to Daytona Beach. I did not observe any visible injuries to Mr. Czipulis' arm, and he stated there were no injuries or discomfort when the incident took place. Mr. Czipulis showed me video footage that recorded the incident confirming his statements.

Based upon my investigation I determined Ms. Brooke Taylor was the predominant aggressor, and in violation of F.S.S. 784.03(1) Simple Battery- Domestic, because she did actually and intentionally, touch or strike Mr. James Czipulis against his will.
