<p>On 07-02-17 at approximately 1313 hours I responded to the area of south Alternate A1A near 3 Palms Plaza (2141 South Alternate A1A) in reference to a fight in progress. Upon arrival I made contact with Michael Kunda, w/m, 07-11-66 (who was later determined to be the victim from my investigation), Rhonda K. Kunda, w/f, 02-23-71 (witness), and Marissa N. Kunda, w/f, 08-19-98 (witness). The other party had left the scene and eventually called the police after he arrived at the hospital telling Officer Collins he "thought I better call the police in case the other guy called" (see Collins supplement).</p> <p>Michael Kunda advised he with his family was driving east on Riverside Drive when he came to a stop at Seabrook Road (the stop sign) when a subject behind him in a Mini-Cooper started to blow the horn. Michael Kunda then approached the intersection of Alternate A1A wanting to turn right (south). Michael Kunda stated he was stopped at the red light waiting for traffic to clear when the subject behind him in a Mini-Cooper started blow the horn. Michael Kunda then turned and tried to get away from the subject (later identified as Bruce Wiita, w/m, 02-28-72). Wiita then sped up in an attempt to get caught up with Kunda. Kunda moved into the left lane to try to get away from Wiita. Then Wiita pulled up on the right side of Kunda's vehicle gesturing with the middle finger and motioning at Kunda. Wiita then passed Kunda and was caught at the next light where Kunda caught up and Wiita was still motioning at Kunda making a circling motion with his finger near his head (as in crazy). Kunda then pulled up on the side of Wiita, rolled down his window and asked Wiita what his problem is? Then Wiita yelled and cursed at Kunda and told Kunda to pull over.</p> <p>Kunda pulled over in the left turn lane in front of 3 Palms Plaza and Wiita pulled in behind him and exited his vehicle. At this point Kunda stated he walked to the rear of his vehicle as simultaneously Wiita exited his vehicle and briskly walked toward Kunda approaching him and quickly jumped in Kunda's face yelling and then chest bumped him,</p>

then after the chest bump Wiita spit in Kunda's face, then rasied his arms as he was going toward Kunda so Kunda pushed Wiita backward. Kunda then stated Wiita tried to hit him but he ducked his head out of the way so Kunda swung and hit him. At that point after a few sings were made, parties separated and went back to their respective vehicles. Kunda pulled directly into the Three Palms Plaza while calling 911 and waited for the Police.

Kunda did have a small cut on his knuckle on his left hand (ring finger knuckle) and no other injuries. Kunda refused medical attention and wrote out a witness statement. In the vehicle was Kunda's wife and daughter, both whom wrote witness statements that corroborated Michael Kunda's story. It should be noted that Kunda's daughter Marissa Kunda showed me a couple videos. One shows Michael Kunda rolling down the window on the right side of Wiita's car to verbally confront Wiita. The next Video is shot through the rear window of the Kunda's SUV. It shows Michael Kunda standing just past the left rear of his SUV (it should be noted the rear "C" pillar is obstructing some of the view of the video due to Michael's close proximity to his vehicle. Wiita's vehicle was pulled up fairly close behind Kunda's vehicle. The two are face to face in the video, I can not see the chest bump or spitting, however when watching the video playback in slow motion, from what is visible is Wiita's right hand and arm starts moving toward and upward to Kunda, Kunda appears to react with his left arm. It appears that Wiita swung first. They then go from view from the back window to the left rear window where it appears both subjects are swinging at each other. Moments later both separate.

Upon arriving at the Jupiter ER, Wiita was very agitated, continued talking over me, asking the same repeated questions as I tried to talk to him, explain what was going on and also get his side of the story. Wiita, had a cut to his lower lip that had been stitched up prior to my arrival and did have blood on the front of his shirt. I asked Wiita for his witness statement, he replied I want to leave and do it later and tried to excuse himself past me to leave. I replied, "sir I am conducting an investigation right now, you are not free to leave besides the hospital has not released you either". I asked again for Wiita to write a statement and he said "no". I asked for his side of the story. Wiita stated he was on Riverside Drive behind Kudna's vehicle and Wiita was aggravated because he was not doing the speed limit. Riverside Drive is a two lane road with a double yellow line that passes through a residential area and is heavily traveled. The speed limit is 25 m.p.h. and 30 m.p.h. on two different sections. Wiita stated he got on Kudna's butt because he was not going fast enough. Then on the Alternate Wiita stated Kudna did 80 mph to catch up to him. It should be noted Kudna was in front of Wiita until Wiita passed Kudna. Wiita said Kudna pointed at him with a finger and he was not sure if he was emulating a gun or pointing to say I am going to get you.

Wiita stated Kudna told him to pull over so he did down the road after Kudna allegedly cut Wiita off forcing him into the left turn lane. Wiita motioned with his hands that

Kudna's vehicle was diagonal across the lane in front of him and when Kudna exited the vehicle it was a straight shot for Kudna to approach Wiita. Wiita then said they rushed each other, chest bumped each other, spit in each others face, then Wiita stated that Kudna punched Wiita twice and that Wiita never tried to hit him. It should be noted that in the video you can see that Kudna's vehicle appears to be parked facing south and straight in the lane with Wiita's car directly behind the rear of Kudna's. It also appears from my investigation and evidence that Wiita was the aggressor in both his driving actions, stopping to confront Kudna, and the physical altercation. Wiita showed me a short video, but all it showed was Kudna slowly pulling into Three palm plaza. Due to my investigation, Wiita admitting he chest bumped and spit on Kudna and Wiita appears to make the first physical move with his hand(s) toward Kudna, I placed Wiita under arrest at 1458 hours for simple battery per F.S.S. 784.03(1)(a)(1) Simple Battery as Wiita did actually and intentionally touch(es) or strike(s) another person against the will of the other.

Wiita received medical clearance, was placed in handcuffs that were double locked and checked for spacing. Then was transported to Jupiter PD for processing. After processing, Wiita was cuffed again and transported to the PB County Jail without further incident.
