


On August 4, 2018, the crime of Lewd or Lascivious Conduct occurred in the 600-block of 54th Street, West Palm Beach, Palm Beach County, Florida.


During a sworn statement, the 11-year-old female victim [REDACTED] disclosed that she went to a nearby store with her two 12-year-old cousins when she observed an unknown white male driving a blue vehicle smiling and waving at them. When they left the store the male stopped his vehicle close to them and said "she's pretty" and "I'll give you \$40.00 to lick your pussy." The victim became scared, returned home, told her family and called 911. She described the vehicle as a medium sized blue vehicle and described the male as an older white male with medium length white hair and wrinkles on his face.

Her two cousins provided consistent sworn statements and video surveillance corroborated the victim's statement.

The investigation revealed the vehicle was registered to Bruce Lawrence (DEFENDANT) and he was driving it at the time of the incident.

During a sworn statement, the DEFENDANT denied the allegations but said he did not remember the incident and that he didn't think he would ever to that. When asked if he would have said the comments because they looked older to him, he said "could have been." He said if he did approach the juveniles in this case, he may have thought they were adults and knew their way around. The DEFENDANT contradicted himself during his statement and there were inconsistencies between



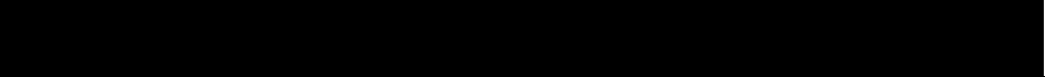
