I spoke with Torres and asked him what happened prior to police arrival and Torres stated the following:</p> <p>Torres stated while he working he noticed an intoxicated customer stumbling while attempting to leave the restaurant. Torres stated he confronted the intoxicated subject by his moped, after the subject got on it and looked as if he was going to drive away. Torres stated at this time the intoxicated subject began yelling profanities at him, got off of the moped and attempted to punch him. Torres stated the entire altercation lasted around two to three minutes and many customers were forced to view the subjects outrage. Torres filled out a witness statement and concluded by stating he does not wish to press charges for the assault, but he did want the subject to be arrested. 

