Torres stated at this time the intoxicated subject began yelling profanities at him, got off of the moped and attempted to punch him. Torres stated the entire altercation lasted around two to three minutes and many customers were forced to view the subjects outrage. Torres filled out a witness statement and concluded by stating he does not wish to press charges for the assault, but he did want the subject to be arrested. Torres also informed me he wanted the subject to be trespassed from the restaurant for a period of six months.

After speaking with Torres I made contact with the subject on the bench and asked him for identification and he stated "Johnson, thats my name". I asked "Johnson" what occurred and he refused to speak with me. I asked Northcom to run the Florida License Plate #MDZM51 which was mounted on the blue moped and I identified the subject to be the registered owner of the moped, W/M Bruce Patterson (2/6/54).
