On 8/12/2018 at 0207 hours I arrived at 527 23rd Ave N in the City of Lake Worth, Florida located in Palm Beach County in reference to a domestic battery investigation.

Prior to my arrival I was advised via dispatch that a father and son were fighting inside of the residence and that one of them was "knocked out" as he had been body slammed. The complainant, Victor Bodero informed dispatch that it was "mayhem" inside of the home and that the door to the house was now locked with his father, Elias Bodero and his brother Bryan Adam's Bodero still inside of the home.

Upon my arrival I observed a white male standing outside of the home hysterically screaming. The white male was later identified as the Complainant, Victor Bodero. I asked Victor what was going on and he told me that he had come home from getting food at McDonald's and upon entering the home he saw his brother Victor Bodero and his father, Elias Bodero fighting inside of the home. He told me that he witnessed his brother picking his father up and body slamming him down on the ground right onto his head. Victor also told me that there had been another male, Orlando Requejo Pupo inside of the home trying to restrain Bryan. I asked Victor who Orlando was and he told me that he was the boyfriend of his mother, Xiomara Viva De-Requejo.

At this time I asked Victor what was going on inside of the home and he began to panic and told me that he didn't know. Myself and D/S Concepcion ID #27814 went to the front door of the home and turned the door handle on the door to open it. As soon as the door opened we glimpsed an older white male wearing a green shirt and dark colored pants sitting on the couch immediately inside of the front door to the residence. This male would later be identified as Elias Bodero. At Elias's feet, was a white male wearing a black t-shirt, blue jeans and converse sneakers lying on his back, seemingly passed out. Myself and D/S Concepcion entered through the threshold of the front door, took one step into the home and immediately noted that the white male lying on the ground, later identified verbally as Bryan Adams Bodero jerked himself into a sitting position and then immediately came to his feet. Bryan's eyes were wide and his lip curled into a snarl as he next proceeded to lunge towards myself and D/S Concepcion. D/S Concepcion moved to the right and I circled around behind him and grabbed Bryans left arm and proceeded to utilize an arm bar takedown to facilitate Bryan's return to the ground. I observed D/S Concepcion mount Bryan from the rear and begin to apply a Vascular Neck Restraint. Bryan was placed into handcuffs by the wrists

which were properly fit, checked for tightness and then double locked. After Bryan had been secured, I went to go speak with Elias to obtain a statement.

Elias told me that "nothing had happened, hes my son, we had a fight". I observed that Elias was bleeding from his nose and there appeared to be a large contusion growing in size on the rear of Elias's head which coincides with the statement provided by Victor in regard to Elias being body slammed.

I next went to go speak with Orlando who informed me that they had all been drinking inside of the residence when Bryan started getting out of control and arguing with his father. Orlando explained that he had attempted to restrain Bryan to prevent him from injuring his father but things had gotten out of control and when the two started fighting, he defended himself and ultimately left after he saw Bryan body slam his father.

Due to my investigation and the verbal statement provided by Victor along with the physical evidence I find probable cause to arrest and charge Bryan with violating F.S.S 784.03(1)(A)(1). I find that Bryan intentionally and willfully touched and struck his father Elias against his will.

Additionally I find probable cause to charge Bryan with violating F.S.S 843.01, Resisting an officer with violence. I find that Bryan did knowingly and willfully resist and obstruct both myself and D/S Concepcion when he jerked to his feet and lunged at both of us with a curled lip and anger clearly displayed upon his face. The offensive move towards us in a low, crouched position showed that he offered to do violence to us. At the time of this action, myself and D/S Concepcion were engaged in a lawful execution of our duties. Both myself and D/S Concepcion were wearing our PBSD issued class B uniforms complete with our issued duty belts along with our Sheriff's Office Badge.

This case is cleared by arrest.
