On the **26** day of **October**, **2017** at **04:10** (Specifically include facts constituting cause for arrest.)

On 10/26/17 at approximately 0204 hours, I arrested Bryan Duffy W/M DOB 04/22/81 for Grand Theft \$300-\$20,000 pursuant to F.S.S 812.014(2C1). The facts are as follows:

On 10/26/17 at approximately 0035 hours, I responded The Breakers Hotel (1 South County Rd) in reference to the theft of a purse and cell phone. Upon my arrival, I met with the victim, later identified as Randee Bank W/F DOB 03/14/61. Banks stated that while she was having drinks at the bar, she noticed that her cell phone and her black purse were missing from the chair next to her. Bank said after realizing her purse and phone were missing, she advised Breaker's Security of the missing items. Banks, her companions, and hotel security all started searching the area for the purse.

While searching for Bank's missing purse and cell phone, Breakers security advised they observed a male, later identified as Bryan Duffy W/M DOB 04/22/81, exit the men's restroom with the black purse in his hands. Security stated after exiting the restroom, Duffy gave the purse to the security officer at the front desk, telling him that he "found the purse in the men's restroom". Breakers security then reviewed video footage from the hotel bar, HMF (where Bank last saw her purse), and the lobby area in front of the men's restroom. Surveillance video from the bar captured images of Duffy removing Bank's purse from a bar stool and walking away. Video from the lobby showed Duffy walking into the men's restroom with the purse partially concealed under his jacket. The purse strap can be seen dangling by his left leg.

When Duffy returned the purse to security, Banks' cellular phone and credit cards were missing. When they searched the men's room, one of the security officers found the phone and credit cards hidden in one of the stalls. The items were found in the toilet cover dispenser, which was located in the wall above the toilet.

Banks did not know Duffy and did not give him permission to take her purse. She signed

an affidavit stating that she wished to prosecute. She said her black Chanel purse was valued at \$4000 and her Iphone 7 was worth \$600.

Duffy was given a Miranda Warning and questioned at the scene. Duffy was shown a still image of himself entering the restroom with the purse strap hanging out from under his jacket. He had a strong odor of alcohol on his breath and person. Duffy denied taking Banks's purse. Duffy later changed his story and said he took the purse, thinking it was his friend's, and was keeping it while she was outside smoking a cigarette. He was unable to explain how the phone and credit cards were found in the toilet cover dispenser.

Based on the facts above, I have probable cause to arrest Bryan Duffy W/M DOB 04/22/81 for Grand Theft \$300-\$20,000 pursuant to F.S.S 812.014(2C1) as he temporarily deprived Banks of her purse and her cell phone.
