The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 9TH day of SEPTEMBER 2018 at 1900 P.M.

On Sunday, September 9th 2018 at approximately 1904 hours I responded to [redacted] in reference to a physical altercation between a uncle and his nephew. Upon my arrival I made contact with the complainant/victim [redacted] who advised he lives at the above mention address with his girlfriend Jordan McDonald, and his uncle Bryan Goldberg. Today at 1900 hours [redacted] was in his bedroom with McDonald when Goldberg erratically walked in and demanded to use McDonald's phone, in which McDonald allowed him. Goldberg was on the phone for approximately 30 minutes when [redacted] asked him how much longer will he be using the phone. Goldberg and [redacted] then began a verbal altercation which escalated to Goldberg slamming the phone on the floor, and began pushing [redacted] on the bed, and putting him in a headlock. [redacted] defended himself by punching Goldberg in the face with a closed fist to separate himself from him. Goldberg continued to come towards [redacted], so [redacted] grabbed a wooden sword but did not use it. [redacted] and McDonald exited the residence and proceeded to call Law Enforcement. I did not observe any visible injuries to [redacted], but his shirt was had been torn and stretched out. I then made contact with McDonald who stated Goldberg entered the room asking to use a phone. When [redacted] asked Goldberg how much longer he would be using the phone he became upset and slammed the phone on the ground and tackled [redacted] onto the bed. The two began physical fighting, [redacted] grabbed a wooden sword but did not use it. I then made contact with Goldberg who advised he had his belongings stolen from him earlier in the day and asked to use McDonald's phone in attempt to locate his lost phone. While using the phone [redacted] became upset and wanted the phone back. [redacted] then for unknown reasons struck him in the face with the wooden sword. He and [redacted] began a physical altercation. I observed minor lacerations to the left side of Goldberg's face. Based on my investigation I find probable cause to arrest Goldberg for Battery (Domestic) per FSS 784.03 (1)(A)(1).
