

I noticed a 2014 Ford Edge bearing Florida license plate COEH61 traveling west in front of me. It was in the middle lane. I noticed the vehicle swerve several times within its lane. The vehicle approached the vehicle in front and started to tailgate before changing lanes to the right hand lane, swerving over the line separating the bicycle lane from the roadway and accelerating rapidly. I put my in car radar (Stalker Dual SL s/n DD005051) in same direction moving mode. I visually estimated the vehicle's speed at 60 miles per hour. I activated the radar and saw the patrol speed matched my own speed. The digital display showed a speed of 60 miles per hour and I heard a clear audio Doppler tone. At about the same time, the lights for Delaware Boulevard turned red. The Ford was able to clear but I was not going to be able to. I activated my lights and sirens to get safely through the intersection and initiate a traffic stop. The vehicle was somewhat slow to stop and rather than pulling into a turn off, pulled over to the far right hand side of the road.</p> <p>I walked up to the vehicle and made contact with the driver and sole occupant, Brian Zufan. Zufan had his window cracked a small amount and was sticking his license out of it. I told Zufan to roll his window down. Zufan dropped the license on the ground outside the car. Zufan rolled his window down. Zufan had ptosis and bloodshot, glassy eyes. I could smell the odor of an unknown alcoholic beverage coming from inside the vehicle. Zufan appeared to be avoiding eye contact and conversation. When Zufan did speak, his speech was mumbled and slurred. Zufan had some difficulty locating his registration and spent several moments inspecting two vehicle registrations in his hand. There was what appeared to be a small bottle of alcohol in the center console cup holder. I asked Zufan how much he'd had to drink. Zufan stated "two drinks".</p>

<p>I moved my vehicle and found a location suitable for Standardized Field Sobriety Tasks. I asked Zufan to exit the vehicle. Zufan was slow to follow my instructions. He fiddled with the climate controls and radio before rolling up his window and turning off his vehicle. When Zufan exited, he appeared very unsteady on his feet and stumbled towards me, causing me to put my hand up to keep some distance between us.</p> <p>I had Zufan go to the back of his vehicle and out of the roadway. Zufan was generally unsteady on his feet and his speech continued to be very slurred. I asked Zufan where he was coming from. Zufan advised me he was coming from the "Square Grouper", which is a bar on the east side of Jupiter. I asked Zufan again how much he'd had to drink, he stated, "one", rather than the two he had stated earlier. I advised Zufan I conducting a DUI investigation. I asked Zufan to do roadsides. He attempted to bargain his way out by asking to have his wife drive him home, then saying he didn't want to do roadsides. I advised Zufan of his Taylor Warnings. Zufan agreed to do roadsides.</p> <p>I started the HGN task. I am a certified Drug Recognition Expert and started to conduct the task in a manner consistent with my training. I observed lack of smooth pursuit, but had to tell Zufan several times to keep his eyes on the stimulus, which he was not doing. Zufan acted confused about ht einstructions and continued to fail to follow them. Zufan then told me he no longer wanted to complete the task. I asked Zufan if he was refusing with the consequences of refusing in mind. He advised that he was. I then made the decision to place Zufan under arrest for DUI. I secured Zufan in handcuffs, which I checked for spacing and double locked. I secured Zufan in the rear of my patrol vehicle and placed the seatbelt on him.</p> <p>I then went to Zufan's car. I noticed that the bottle of alcohol had been moved from the cup holder and was no longer in sight. I found the bottle on the rear floorboard of the vehicle, directly behind the driver's seat. It was a 50 ml bottle of Patron Tequila. It was open and half of the liquid was gone. The liquid had a distinct odor of an unknown alcoholic beverage. I took pictures of the bottle and uploaded them to evidence.com.</p> <p>I transported Zufan to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period. I then requested that Zufan provide a sample of his breath. He declined. I read Implied Consent from a prepared text. Zufan stated he understood and again refused to provide a sample of his breath. I then read Zufan his Miranda Rights. Zufan declined to speak to me.</p> <p>I secured Zufan in a holding cell while I completed my paperwork. I then booked Zufan into the Palm Beach County Jail, where I charged him with DUI per FSS 316.193(1).</p> <p>My on scene investigation was captured on my issued body worn camera.</p>
