On the **19** day of **April**, **2018** at **14:22** (Specifically include facts constituting cause for arrest.)

On Thursday April 19, 2018 at approximately 0833 am I was dispatched to 9137 Alternate A1A North Palm Beach FL, 33408 (Hertz) in reference to an overdue car rental. On arrival I made contact with the Branch Manager Mauricio Ortiz (H/M D.O.B. 03/02/1973) who stated that a vehicle which was rented on 03/07/2018 was due to be returned on 03/28/2018, but it was never returned and he wished to report it stolen at this time. Mauricio also told me as well as showed me documentation of multiple attempts made by Hertz to make contact with the renter (Caitlin Boltz W/F D.O.B. 02/01/1991) requesting the vehicle be returned. The documents included a certified letter which was sent out on 04/11/2018. The stolen vehicle is a 2018 Buick Envision bearing FL tag JAHS68 (VIN # LRBFX1SAXJD017298). Hertz provided me with Caitlin's phone number, and I made multiple calls which were unsuccessful. Caitlin did answer the phone once and as I introduced myself, she hung up the phone. I called her again and left multiple messages on her answering machine. Mauricio filled out a Stolen Vehicle Affidavit while I was attempting to make contact with Caitlin.

During my investigation I asked Mauricio if the vehicle was equipped with LoJack or another form of tracking devise to which he told me the vehicle was equipped with OnStar. I called OnStar and spoke with advisor Randall who made a call to the vehicle and was able to speak with Caitlin. Randall stated he was unsuccessful in maintaining Caitlin on the line long enough the resolve the issue. I asked Randall if he could track the vehicle to which he informed me that he cannot track the vehicle until it has been entered as stolen. At that time I advised Randall that the vehicle is stolen and being entered into NCIC/FCIC and provided him with the North Palm Beach Police Department (NPBPD) case number. Randall provided me with an OnStar reference number (#158152329), placed an ignition stop on the vehicle and started to track its movement. All tracking information was given to NorthComm dispatch center which alerted the proper jurisdictions in reference to the location of the vehicle. I completed the perfect form and the vehicle was entered as stole into NCIC/FCIC by NorthComm (NIC #V300232782).



At that time I provided Mauricio with an assigned NPBPD case number as well as a Victim's Rights Brochure. As I was completing this report I was advised by NorthComm that the vehicle was tracked and that Lake Clark Shores Police Department and FHP had recovered the vehicle at 1497 Forest Hill Blvd. Palm Springs FL, 33406. Lake Clark Shores Officer Connacher ID 322 recovered the vehicle and had a B/M (later identified as Kevin L. Holland D.O.B. 01/12/1967) detained. Officer Connacher advised the vehicle was drivable and that the keys were with the vehicle; Lake Clark Shores Police Department recovery case number LCS18-000652. NorthComm removed the vehicle from NCIC/FCIC and notified Hertz (Mauricio) on the location of the vehicle, which sent a Hertz employee to retrieve the vehicle. Lake Clark Shores also advised that Caitlin was not with the vehicle at the time of the recovery and that Kevin was not arrested by them. It should be noted that FHP did arrest Kevin on drug charges.

Based on my investigation I believe probable cause exists to charge Caitlin Boltz (W/F D.O.B. 02/01/1991) for Grand Theft of a Motor Vehicle and failure to return rented vehicle. Caitlin Boltz (W/F D.O.B. 02/01/1991) did knowingly obtain or use, or endeavor to obtain or use the vehicle of a value of \$300.00 or more, which was the property of Hertz Vehicles LLC., or any other person not the defendant(s), with the intent to permanently or temporarily deprive Hertz Vehicles LLC., or any other person not the defendant(s) of the property or benefit therefrom or to appropriate the property to the use of Caitlin Boltz or to the use of any person not entitled thereto, contrary to Florida Statute 812.014(2)(C)(6) and did unlawfully, after hiring 2018 Buick Envision, a motor vehicle under an agreement to redeliver the same to Hertz Vehicles LLC., the person letting such motor vehicle, or his/her agent, at the termination of the period for which it was let, did, without the consent of Hertz Vehicles LLC. and with intent to defraud, abandon or willfully refuse to redeliver such vehicle, as agreed, contrary to Florida Statute 817.52(3).

I turned in all documentation provided by Hertz, stolen vehicle affidavit, State Attorney Filing packet and Probable Cause Affidavit to North Palm Beach records. No further information at this time.
