left paved emergency shoulder. When I arrived on scene I observed a black in color Honda bearing a FL tag of Y82XTH behind a white in color pickup truck which was later identified to have been the witnesses vehicle. I also a white male and female in front of a Hispanic male who was leaning on his back against the concrete barrier wall. As I approached the individuals standing outside on the side of the roadway, the white male and female advised that the Hispanic male was the one in the black in color Honda and that they pulled out of the vehicle due to him being asleep behind the wheel (see witness statements). I then made contact with the Hispanic male who immediately advised me that he was driving under the influence. The Hispanic male driver was later identified through his Florida driver license to be, Camilo Andres Fonseca 10/07/1994. Standing in front of Mr. Fonseca outside on the side of the road, as he spoke to me I could smell the odor commonly associated with the smell of an unknown alcoholic beverage emitting from his breath. Mr. Fonseca was questioned on where he was coming from, where he was heading too, if he had been drinking and where he had been drinking. Mr. Fonseca advised me that he doesn't know how he got where is now and that he was coming from Delray Beach. Mr. Fonseca advised me that he was drinking at Hurricanes to which I then asked when his last drink was to which Mr. Fonseca advised me that he did not know when his last drink was. Mr. Fonseca's speech was thick and slurred along with droopy bloodshot glossy eyes. Mr. Fonseca was then asked to follow me to the front of my patrol vehicle resulting in me observing Mr. Fonseca's to lose his balance and have an unsteady walk. Mr. Fonseca was then asked if he was okay to which he responded he had already been drinking. As Mr. Fonseca continued to speak to me I was able to still smell the odor commonly associated with the smell of an unknown alcoholic beverage emitting from his breath as he spoke to me. Due to the information I was provided by the witnesses who observed Mr. Fonseca asleep behind the wheel while in full physical control of it and the key fob in his pocket and the observations I observed upon Mr. Fonseca on the side of the roadway I had reason to believe that Mr. Fonseca was operating a motor vehicle under the influence of alcohol and/or a controlled substance. Mr. Fonseca was then requested to perform a series of roadside exercises to which he refused to perform. Mr. Fonseca was advised that if he decided to refuse to perform the exercises I was requesting of him I would base my decision off the information that was provided to me and everything I have observed. Mr. Fonseca refused to perform the roadside exercises once again.

Due to the totality of the circumstances Mr. Fonseca was placed under arrest for DUI pursusant to chapter 316.193.1 of the Florida State Statute revised. Mr. Fonseca was then searched and placed in my patrol vehicle where he was then transported to the Palm Beach County Jail. Mr. Fonseca was then taken into the breath alcohol testing facility where he then began his 20 minute observation where I sat in a manner that I was able to observe him. After Mr. Fonseca's 20 minute observation he was then given an opportunity to submit to an approved test of his breath for the purpose of determine the alcohol content in which he consented to provide. Mr. Fonseca's first breath was provided at 0100 resulting in a .251. Mr. Fonseca's second breath was provided at 0103 resulting in a .237.


