
I responded to 1002 W Ocean Boulevard, Boynton Beach, FL in reference to a disturbance. W/F Michelle Redman (DOB 01-16-1972) came to the BBPD lobby to state she had been in a verbal argument with her room mate, W/F Candace Cabot (DOB 05-28-1963). Please see Ofc. Bundrick's supplement to this report for more information.

Upon my arrival, I made contact with Officers already on scene, who stated that upon their arrival to the residence, W/M Jerry Langley (DOB 08-23-1948) advised Candace had poured urine on him while he slept. I then made contact with Jerry, who provided me with a sworn statement. According to Jerry, he was sleeping in his bedroom when he was awoken by a wet, warm sensation to his face and upper chest area. Upon waking up, Jerry stated he immediately observed Candace standing over him bedside stating the following: "you crippled motherfucker, I am going to kill you". It should be noted that Jerry is physically disabled and needs assistance walking, therefore he has a urinal next to his bed for when he has to use the restroom. Also, earlier on the same day, BBPD units responded to the same address in reference to a disturbance involving the same parties, where Candace was ultimately arrested for Filing a False Police Report (BBPD case number 18-014516). Upon speaking to Jerry, I detected a strong odor of urine emanating from his person. Jerry also had wet stains on the upper area of his t-shirt, which was visibly moist. The bed which Jerry was laying down was also visibly moist and also had a urine odor. The urinal which stays next to Jerry's bed was nearly empty with only a small amount of urine still within. After the incident, Jerry called his brother, W/M Timothy Langley (DOB 10-28-1965), who reported the incident to Michelle. Michelle then ultimately came to the BBPD lobby to report the incident.

I then made contact with Candace who was read her Miranda rights. Candace stated she understood her rights and provided me with a statement. According to Candace, Jerry placed urine on himself in order to get her into trouble. Candace denied pouring urine on Jerry and stated she was sleeping during the incident. Candace was unable to clarify at which exact point she observed Jerry had urine on his person. Candace's story was inconsistent and did not support the evidence available to me on scene, nor was she able to dispel any of my fears that a crime had been committed. Candace was also unable to elaborate on specific events from tonight and evaded my questions multiple times by mentioning unrelated subjects. It should also be noted that the moist splash stains left behind on Jerry and bed are consistent with a person standing over him bedside and pouring urine on him. Based on that, it is apparently impossible for a person to pour urine on themselves and replicate the splash pattern.

Based on the above facts and circumstances, at this time I find probable cause to charge Candace with one count of misdemeanor Simple Battery, pursuant to FSS 784.03(1A1). A FCIC/NCIC/PALMS check for active warrants was conducted on Candace, yielding negative results. Candace was transported to BBPD headquarters for processing and subsequently TOT PBCJ. Nothing further.
