I advised the defendant that I concluded my DUI investigation and, based on the observational clues on the SFST's determined that she was too impaired to operate a motor vehicle and placed the defendant under arrest for DUI. The defendant verbally stated that she understood. She asked me to administer a "breath test" on the side of the road and pleaded with me to let her go. I placed the defendant in handcuffs that were checked for proper fit and tightness and double locked and placed defendant in the rear of my PBSO marked patrol vehicle and transported the defendant to the B.A.T. (Breath Alcohol Testing) facility. Once at the B.A.T. the defendant was observed for a period of twenty minutes, during which time the defendant did not ingest anything, place anything in her mouth regurgitate or vomit. After the twenty minute observation period the defendant was placed on camera and asked if she would submit a breath sample for the purpose of determining its alcohol content and the defendant consented. The defendant provided two breath samples and the results were .000 for the first breath sample and .000 for the second breath sample. The results were given, and explained to the defendant and the defendant verbally stated that she understood. Noting that the signs of impairment the defendant displayed were not consistent with the breath samples provided, I then asked the defendant if she would submit to a lawful test of her urine for the purpose of detecting the presence of chemical or controlled substances. The defendant verbally consented. I did read the defendant Florida Implied Consent on camera and explained to the defendant that it would only apply if the urine sample was not provided once we were off camera. She verbally stated that she understood Implied consent and again verbally stated that she wanted to provide the sample. I read the defendant her Constitutional warnings on camera and the defendant verbally stated that she understood her rights. The defendant cooperated with Q&A. During Q&A, when asked "What have you been doing for the last three hours?" the defendant faintly replied, "Doing drugs" and when I asked her to speak up she replied, "I was drinking". When I asked, "Have you smoked any marijuana or done any drugs today?" the defendant rocked back in forth in her chair and did not give a response. I asked if she heard and understood the question but still did not give a response and I moved on to the next question.

The defendant successfully provided a sample of her urine at 0324 hours after five glasses of water. The defendant however refused to have an evaluation completed by a D.R.E. (Drug Recognition Expert). I issued the defendant a Uniform Traffic Citation for DUI pending toxicology results and transported the defendant to the main detention center, without incident, for booking and processing. The urine was placed into evidence for toxicology screening.

This case is cleared by arrest.

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 04/15/2017, at approximately 0130 hours, I responded to the area of Hagen Ranch Road and Moultrie Drive in Boynton Beach, located in Palm Beach County, Florida reference a traffic stop. Upon arriving on scene I made contact with Deputy C. Ward #16305 who advised that he was parked on the side of the road, in the northbound lanes of Hagen Ranch Road just north of LaChalet Blvd, when he witnessed a black Mercedes SUV bearing Florida tag HLJC79 travel north of his location at approximately 20MPH in a 45MPH zone. He pulled out onto the roadway behind the vehicle and the vehicles right blinker came on and the vehicle pulled off the right side of the roadway crossing the white fog line. Without activating his emergency lights, D/S Ward stopped behind the vehicle to conduct a welfare check on the driver. He approached the driver's side of the vehicle and identified the driver and sole occupant of the vehicle as Candice Lyod Pierre (defendant) DOB: 07/20/1991 by her Florida issued driver's license. The driver opened the door, rather than putting the window down, and D/S Ward could smell a strong odor of an unknown alcoholic beverage. D/S Ward could see that in the back seat, in plain view, there was a can of Mike Hard Strawberry Lemonade. He requested for a DUI investigator to respond to the scene.

OBSERVATION OF DRIVER:

When I arrived on scene the defendant was still seated in the driver's side of her vehicle. I approached the driver's side door and made contact with her. I immediately noticed an overwhelming odor of an unknown alcoholic beverage coming from within the vehicle. I observed the defendant's eyes were glassy and had a glazed look to them. The defendant was slow to respond but she did step out of the vehicle. I observed her speech to be slow but not slurred or heavy. I relocated the defendant to the front of my patrol car, and with my in car video system activated, I advised the defendant that I was conducting a DUI investigation to see if she was too impaired to operate a motor vehicle. The defendant verbally stated that she understood. I observed that the defendant swayed in a front and back and circular motion while she stood in a resting position. The defendant was talkative, kept repeating herself and asking the same questions. As she spoke I could smell a faint odor of an unknown alcoholic beverage emanating from her breath. The defendant stated that she was on her way home from the store and she slowed down because she saw the patrol car off the roadway and that she pulled off the roadway because she was letting the "emergency vehicle" pass. She further stated that she consumed one Corona beer at home, went to the store to buy another beer that she started drinking at the gas station and she tossed into the back seat of her vehicle when D/S Ward stopped to check on her.

DRIVER'S STATEMENTS:

She denied having any physical disabilities or injuries but stated that she has high blood pressure. She denied taking any prescription medications and stated she takes a water pill. I asked the defendant if she would submit to voluntary SFST's to dispel my suspicion that she was under the influence and she verbally consented. I used a pre-painted line on the side of the roadway that was free of debris and away from through traffic.

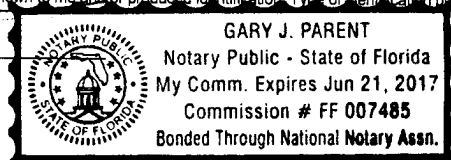

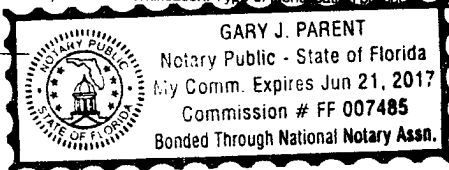
