	On Friday, 04-21-17 I responded to 456 Broward Avenue Greenacres, FL 33463 at approximately 1855hrs, in reference to a disturbance. Upon arrival, contact was made with the defendant, W/M Carlos H. Azpiazu-Marrero DOB: 10-14-78.										
	While arriving on scene, I observed Azpiazu-Marrero actively striking a car window with his right fist in the middle of the street. The vehicle in question allegedly belonged to his ex-girlfriend. I immediately ordered Azpiazu-Marrero to lay down on the ground and was essentially placed into custody for his disorderly conduct. It is to be noted that Azpiazu-Marrero was highly intoxicated during the entirety of his disturbance. His disturbance caused nearby residents to exit their homes and witness what the disturbance consisted of. Azpiazu-Marrero became belligerent throughout my entire encounter with him and began slamming his forehead against the window divider of my patrol vehicle.										
ADMINISTRATIVE	Based on my observations and investigation conducted, probable cause exists to charge Carlos Azpiazu-Marrero with disorderly intoxication pursuant to FS 856.011. He was transported to the Palm Beach County Jail without incident.
