On Tuesday June 25th, 2019, The PBSO District 14 Street Crimes Unit conducted an undercover operation within the City of Lake Worth to combat Street Level Prostitution. Female Deputy Sheriffs posed as prostitutes in specific locations due to citizen's complaints. D/S [REDACTED] was one of the 'decoys' posing as a prostitute in the 300 block of North Dixie Highway in the City of Lake Worth FL.

D/S [REDACTED] was approached by a W/M later identified as Carlos Madrid who was driving a BLUE GMC SIERRA Bearing FL Tag# KPU-H27. Upon the defendant's contact with the deputy, a conversation ensued. During the conversation, Defendant pulled up to D/S [REDACTED] and asked if she was working. D/S [REDACTED] replied "Yes". Defendant unlocked the doors and asked D/S [REDACTED] to get in the vehicle. D/S [REDACTED] replied, "are you wanting something from me?" Defendant stated "yes I want to have sex with you". D/S [REDACTED] replied "Ok, do you have cash on you?" Defendant replied "Yes, sixty dollars". Defendant and Deputy agreed to meet in the alleyway around the corner.

A predetermined signal was given where the arrest team responded from a concealed location. Deputies stopped the Defendant and took him into custody without incident. The Defendant was placed in zip cuffs that were checked for fit and was transported to the District 14 substation for processing.

The Defendant requested his vehicle be parked at the 700 block of North Dixie Highway. The audio of the transaction was packaged and entered into evidence at the D-14 Sub Station.

Based on the above aforementioned facts I find Probable Cause exists for the arrest of the DEFENDANT for SOLICITING ANOTHER TO COMMIT PROSTITUTION per F.S.S 796.07 (2)(F).
