In the early morning hours of Sunday November 16th, 2019 at approximately 04:08 hrs. I, Sgt. A. Vanyi #7296 was driving westbound in a marked PBSO vehicle on State Road 80 near the intersection of "E" Road in unincorporated Loxahatchee, Palm Beach County Florida. While driving westbound I observed headlights facing my direction in the westbound lanes of the poorly lit roadway. It appeared a vehicle was driving on the wrong side of the divided roadway. As the headlights closed the distance, it was clearly apparent a vehicle was in fact driving on the wrong side of State Road 80. A white Hyundai Sonata 4 door bearing Florida Tag #HAJZ02 passed my patrol vehicle and I activated my emergency lights to warn another patrol vehicle behind me operated by Sgt. R. Nandlal #8483. The wrong way vehicle was spotted by Sgt. Nandlal and he too activated his emergency lights and stopped the vehicle in the median of the divided roadway. The driver was identified with a Florida DL as Carlos Perdomo. The driver had strong smell of a alcoholic beverage on his person according to Sgt. Nandlal. The driver stated he was unaware he was driving on the wrong side of the roadway. It was believed the driver was impaired and I contacted Deputy P. Zeitz # 24970 of the DUI Unit to conduct an investigation. This incident was capured on video. This includes my involvement.

On November 16th 2019 at approximately 0408hours, I was driving west bound on Southern Blvd (State Road 80) in my marked PBSO vehicle. Southern Blvd is (2) lanes west bound and (2) lanes east bound. I noticed a white 4 door vehicle traveling east bound in the number 1 west bound lane of travel (tag HAJZ02). I noticed another vehicle also traveling west bound quickly moved over to the number (2) lane to avoid hitting the white vehicle on a head on collision. Sergeant Vanyi was just ahead of me driving west bound and also witnessed said vehicle. Sergeant Vanyi and I both turned around immediately in our marked PBSO vehicles and activated our emergency lights to gain the driver's attention of the white vehicle, in order to avoid a head on collision. The driver eventually pulled into the center median of Southern Blvd and E Road. I made contact with the driver who was identified by his drivers license as Carlos Perdermo. Carlos told me that he was coming from Wellington and was on his way home to Boynton Beach. I asked Carlos if he knew that he was driving on the wrong side of the road and he replied no. I noticed that Carlos speech was slurred and his eyes appeared glassy. Based on my past training and experience, I believed that Carlos may have been intoxicated. I asked Carlos if he had any alcoholic beverages to drink tonight and he told me that he had a couple of beers. DUI 13 arrived on scene and took over the DUI investigation.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I was dispatched to the area of Southern Blvd and E Rd. in Loxahatchee, FL in reference to a vehicle traveling Eastbound in the Westbound lanes of Southern Blvd. Upon arrival I met with Sgt. Nandlal #8483 and Sgt. Vanyi #7296 who informed me of the following:

Sgt. Nandlal and Sgt. Vanyi were traveling Westbound on Southern Blvd when they observed a vehicle traveling Eastbound towards them in the Westbound lanes. After the vehicle passed them, Sgt. Nandlal turned around and conducted a traffic stop on the white Hyundai bearing FL tag HAJZ02. The driver of the vehicle was identified as Carlos Perdomo by his FL driver license. Sgt. Nandlal observed a number of articulable indicators of impairment and called for a DUI unit to respond to conduct a DUI investigation. Both Sgt. Nandlal and Sgt. Vanyi provided supplements detailing their observations.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by his Florida driver license as Carlos Perdomo, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from his person and breath. This odor intensified as I spoke to him. Perdomo had glassy, glazed, and blood shot eyes. His speech was slurred, slow, thick, and at times difficult to understand. His movements were slow, deliberate, and lethargic with poor coordination. Perdomo had an unsteady gait while walking to my patrol vehicle and had difficulty following directions given to him. *Perdomo was wearing a blue jacket, blue jeans, and brown shoes.

DRIVER'S STATEMENTS:

Pre-Miranda: Stated that he was drinking with a friend at a bar and had a couple beers. Perdomo did not know why he was driving Eastbound in the Westbound lanes and did not know where he currently was.

Refused to participate in Q&A post Miranda.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from his person and breath which intensified as I spoke to him.

GENERAL OBSERVATIONS

SPEECH: Perdomo's speech was slurred, slow, thick, and at times difficult to understand.

ATTITUDE: Lethargic but cooperative

CLOTHING: Blue jacket with blue jeans and brown shoes

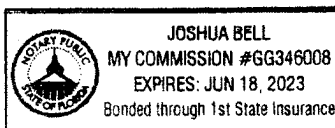

Other Observations:

Perdomo would sway roughly in a side to side front to back pattern throughout the task. He was reminded numerous times to track the pen with his eyes only. Perdomo failed to keep his head still while tracking the stimulus. LOC was observed.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Perdomo who stated that he understood. During the task, I observed him to sway roughly in a side to side, front to back pattern throughout the demonstration phase. He could not maintain his balance while listening to instructions. He stepped out of the instructional stance during the demonstration to catch his balance. Perdomo started the task before being instructed to do so. Perdomo missed heel-to-toe steps and stepped off the line. He also performed the incorrect number of steps by performing 10 steps on the 2nd set of steps.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Perdomo who stated that he understood. During the task, I observed him to sway roughly in a side to side, front to back pattern throughout the demonstration phase. He continued to sway while balancing on one leg. Perdomo used his arms to balance raising them more than 6 inches from his sides. He started hopping in an attempt to maintain balance. He put his foot down to regain balance numerous times before the 30 seconds had elapsed.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to Perdomo who stated that he understood. During the task, I observed him to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Perdomo did not keep his eyes closed and had to be reminded. He failed to return his arms down to his sides as instructed after touching his nose. Perdomo's index finger did not touch the tip of the nose on 5 of 6 attempts. He used the hand other than that which was called before self-correcting. The sequence used for this task was L, R, L, R, L, R, L.

ROMBERG ALPHABET:

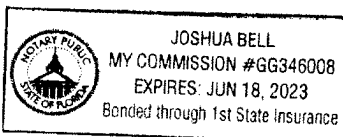
I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Perdomo who stated that he understood. During the task, I observed him to sway roughly in a side to side, front to back pattern throughout the demonstration phase. He would sway more than 2 inches. Correctly counted from 1 to 26.

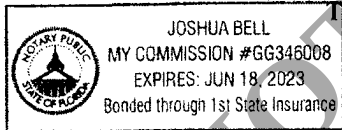
