PERSONAL CONTACT

NARRATIVE:

On July 8 2018 at approximately 0718hrs I was dispatched and responded to 4297 Line Drive Palm Springs, FL 33461 in reference to a domestic disturbance. Upon arriving I made contact with Carlos Solis, suspect. Solis was standing outside of the above address along with his wife, Adrianna Rodriguez, victim and their minor child in common, Emanuel Solis. Solis appeared to have trouble standing and as I made further contact with Solis he appeared to have trouble speaking fluidly and was slurring his words. Furthermore, Solis's eyes were bloodshot and the smell of an unknown alcoholic beverage was imitating from his person. Also on scene: Sgt. Collura #118 and Ofc. Hite #155.

Solis stated that he was not allowing Rodriguez in their shared residence because she was sleeping with another man. Solis stated Rodriguez arrived home at approximately 0600hrs and that was unacceptable. Solis stated he pays rent at the above location and was forbidding Rodriguez to live there any longer because he knew she was having an affair.

I made contact with Rodriguez, who appeared distraught and was crying. Rodriguez stated that she had been working at a restaurant overnight and when she returned to her residence at approximately 0600hrs she found Solis standing outside drinking a canned beer. Rodriguez stated she attempted to enter the residence and Solis forbid her and told her she was a whore. Rodriguez stated she told Solis to move out of her way and he refused. Rodriguez stated Solis pushed her back from the door way, grabbed her car keys and threw the can of beer at her person; striking her on the right cheek bone. Solis displayed a slight red mark on the mentioned area of impact. Rodriguez stated Solis then went inside the residence, locking her outside. Rodriguez stated shortly thereafter Solis exited the residence with their minor son, who was crying and stated he was going to call police and tell them she was having an affair (Solis did so). Rodriguez stated Solis continued to verbally insult her in front of their son as police arrived.

Photos of the victim were taken and later submitted as evidence. The victim completed a Sworn Victim Statement Form and signed for a Domestic Violence pamphlet. DCF was contacted. The victim refused a recorded statement as she did not want to further upset her son. Rodriguez refused medical attention.

Solis was arrested and charged with Simply Battery (Domestic) in accordance with F.S.S. 784.03(1)(a)(1). Solis was handcuffed to his rear, cuffs were checked for proper spacing and double locked. Solis was transported to the Palm Springs Police Department for completion of paperwork and later transported and turned over to Palm Beach County Jail.

DEFENDANT'S STATEMENTS: (Written / Taped / Oral)

Solis stated that he was not allowing Rodriguez in their shared residence because she was sleeping with another man. Solis stated Rodriguez arrived home at approximately 0600hrs and that was unacceptable. Solis stated he pays rent at the above location and was forbidding Rodriguez to live there any longer because he knew she was having an affair.

VICTIM'S STATEMENTS: (Written / Taped / Oral)

I made contact with Rodriguez, who appeared distraught and was crying. Rodriguez stated that she had been working at a restaurant overnight and when she returned to her residence at approximately 0600hrs she found Solis standing outside drinking a canned beer. Rodriguez stated she attempted to enter the residence and Solis forbid her and told her she was a whore. Rodriguez stated she told Solis to move out of her way and he refused.
