Probable Cause

I, Officer Darryl Loach, observed the subject driving at high speed and swerving across all lanes of the I-95 with disregard for other road users. I switched on my emergency blue lights and siren to initialize a traffic stop to address the infractions. The subject did not stop and continued driving at high speed for approximately four mile crossing over lanes. The subject started to pull away from me. I observed the vehicle exit at 10th street, where it came up behind another vehicle stopped at the red traffic signal. I parked behind the subject and made contact with the driver, later identified as Carmen Antonia Granados. During my contact with the subject, i could smell the strong odor of alcohol coming from her breathe, her eyes were glassy, her speech slurred and was unable to follow my instructions.

A. Phase 2 – Personal Contact with driver/operator of vehicle/vessel
I, Officer James Brodbeck of FWC arrived on scene at approximately 0240 hours. I made contact with the operator of the vehicle, identified by Florida Learner's Permit as CARMEN A GRANADOS. GRANADOS had a strong odor of an alcoholic beverage emitting from her breath, glassy, bloodshot eyes, and was making incoherent statements. Her speech was slurred. I asked GRANADOS if she would complete Field Sobriety Tasks, and she agreed. When she stood up, she was swaying and unsteady on her feet.

B. Phase 3- Pre-arrest screening and Observations of Driver/Operator
HGN: During Horizontal Gaze Nystagmus, GRANADOS displayed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and an onset of nystagmus prior to 45 degrees in both eyes. GRANADOS also displayed Vertical Nystagmus, and moved her head during the task.
WAT: During Walk and Turn, GRANADOS had difficulty placing her feet in the demonstrated position at the beginning of the task. On the first 9 steps, she counted to 10, and missed contact on steps 2, 3, 4, 5, 6, 7, 9, and 10. On step 9 GRANADOS also stepped off the line/stumbled.
GRANADOS did not turn as instructed and stumbled.
On the return 9 steps, GRANADOS counted to 13, and missed contact on steps 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, and 13. She also stepped off the line/stumbled on step 7.
OLS: During One Leg Stand, GRANADOS did not count as instructed, put her foot down on 2, put her foot down on 5, and stopped the task/stumbled.

C. Arrest of Driver/Operator
At 0300 hours, I placed GRANADOS under arrest for suspicion of DUI. While in custody, she slipped

her handcuffs and urinated in my patrol vehicle. I transported GRANADOS to the Palm Beach County Jail, where she provided breath samples of 0.213 and 0.206 g/210 L of breath. She was also belligerent and hostile to the jail staff while in custody, displaying large mood swings, ranging from crying to anger. *SUBJECT ALSO CHARGED WITH F.S. 562-11(1) MARIJUANA IN POSSESSION*
