On the 1st day of September 2018 at 02:50 A.M. P.M. (Specifically include facts constituting cause for arrest.)

On September 1st, 2018 at approximately 0255 hours, I responded to 106 North Military Trail (Rumbass Nightclub) in unincorporated West Palm Beach, Florida, in reference to a battery in which a security advised he had been bitten by a female who was also refusing to leave.

Upon my arrival I made contact with the victim/complainant, Tony Gorgos Ruiz, who is an armed security guard for Delta Tactical Force Protection, employed by Rumbass Nightclub. I observed that he was wearing a clearly identifiable uniform, with black ballistic vest, displaying a clearly labeled security badge in the upper left chest portion of his vest, along with a patch on the back of his vest which reads "SECURITY." He also had a badge on his waist stating the same and was clearly identifiable as a Security Guard. Ruiz, who had already detained the female in handcuffs, stated to me that the female, identified by FLDL as Carolina Contreras, was kicked out of the nightclub for attacking another customer. Ruiz added that Contreras was belligerent and had to be escorted outside. Ruiz added that Contreras was asked to leave at least 3 times, to which she refused. Ruiz advised that on the 4th time that she refused, he attempted to walk Contreras to a vehicle when she turned and bit him on his left forearm. He stated that he detained Contreras and called 911. A check of Ruiz' left forearm showed redness, swelling, and fresh tooth marks. Ruiz advised that he wished to press charges and he completed a written sworn victim statement.

I attempted to speak to Contreras, however, she was continuously screaming/cursing in my face, and repeating random portions of her evening nonsensically. During this initial encounter, I could smell a heavy, and strong odor of an unknown alcoholic beverage emanating from her body and breath. The continuous screaming from Contreras was causing a large scene, resulting in multiple spectators to come over to the area to see what was happening. Numerous people who were standing by and observing the profane behavior had stopped while on their way toward the nightclub and subsequently turned around to leave. I asked Contreras to stand up so I could remove Ruiz' handcuffs and place my handcuffs onto her wrists, where she began to again scream/yell in my face causing another scene. I assisted Contreras in standing up, and escorted her to the rear passenger door of my marked PBSO patrol vehicle where Contreras refused to get in. Contreras was asked repeatedly to enter the vehicle and she continued to refuse. At this time Contreras attempted to walk away from my grasp, where I then escorted her into the vehicle. It should be noted that Contreras was initially trespass warned by Ruiz, however verbally refused to leave.

Once in the vehicle, Contreras began to make spitting noises, and was told to not spit in the vehicle numerous times. While enroute to JFK Hospital for medical clearance, Contreras began to make deep snorting noises as if she was clearing her sinuses to spit heavy, viscous mucus. Contreras then started to spit thick, sticky mucus into the interior of the vehicle and became very combative. Contreras was informed during this outburst that she was being recorded with onboard cameras, where she began to make threats. As I pulled into the parking lot of JFK Hospital, Contreras began to escalate her combative behavior. It was at this point the determination was made to bring Contreras to Delray Medical Center North, which is a facility that is better equipped to accommodate a violent and combative subject. *****CONTINUED ON PAGE 2*****

While arriving at Delray Medical Center North, Contreras, who was still screaming and spitting, began to wipe her forehead back and forth on the plastic divider where she had spit, in an apparent attempt to remove the spit before anyone could properly observe it or collect it as evidence. Contreras was examined, medically cleared, and placed back into my vehicle for transport to the Palm Beach County Jail. While enroute to the jail, Contreras again began to scream, and yell obscenities. Contreras refused to get out of the vehicle once at the jail, again needing to be escorted into the initial holding area, where she continued her belligerent behavior. Her behavior was so combative that PBSO Jail Deputies had to secure her in a special holding area to prevent injury to herself and others. It should be noted that while Contreras was in custody, she received numerous text messages, displayed in plain view on the front of her cell phone, indicating that she was trying to purchase Marijuana. I did not, however, discover any illegal substances on her person, search incident to arrest.

Based on my investigation, I determined that Contreras did commit the following acts:

Battery on Security Officer - by knowingly and willfully biting a security guard, in full uniform, with agency insignias and badge prominently displayed, while on duty and working as such, without his consent, and with the intent to cause harm therein, pursuant to FSS 784.07(2)(b)

Trespassing - by knowingly and willfully refusing to leave the property at Rumbass Nightclub after being asked to leave approximately four (4) times by Security, pursuant to FSS 810.08(2)(b)

Disorderly Intoxication - by knowingly and willfully screaming obscenities/profanity in front of a fully populated business, while intoxicated by unknown alcoholic beverage, to which her behavior alarmed patrons of the establishment, causing them to leave, pursuant to FSS 856.011(1)

Resisting Officer without Violence - by knowingly and willfully repeatedly refusing my lawful commands, while in the course of my official duties, with the intent to hinder/obstruct/delay my investigation, pursuant to FSS 843.02

Criminal Mischief (less than \$200) - by knowingly and willfully spitting thick, viscous, sticky mucus all over the backseat and partition of the patrol car, causing damages under \$200, through extensive decontamination labor and costs, without legitimate purpose, and with the intent to cause damages therein, pursuant to FSS 806.13(1)(b)(1)

Tampering with Evidence - by knowingly and willfully attempting to hide/remove her saliva/mucus from the rear partition after spitting all over it, with the intent to conceal and thus destroy the evidence prior to collection with the intent to hinder/obstruct my investigation and also to prevent its collection and use in criminal proceedings, pursuant to FSS 918.13(1)
