


Multiple complaints have been received by our department in reference to these issues and this operation was conducted to help rid this area of some of these crimes and ordinance violations. On this date, Officer Noel was in plain clothes in the downtown area to see if he could witness any of these crimes.</p> <p>At approximately 1410 hours Officer Noel was walking in the 200-Blk. of Clematis St. on the sidewalk when he was approached by a W/F, later identified as Caroline Schools 10/27/1974. Upon approaching him Schools solicited Officer Noel for money stating that she needed it to buy a beer. Officer Noel subsequently pulled a single dollar bill from his pocket (S/N: G75062571F) and handed it to Schools. It should be noted that panhandling/soliciting individuals for money in the downtown area is a violation of City of WPB Code 54-147. Schools then walked out of the area on foot. Officer Noel later relayed this information to me as he was trailing Schools to track her location. I later arrived in the area and made contact with Schools at the intersection of Datura St. and S. Dixie Hwy. Schools was wearing a pink shirt/tank top and dark colored hat as was described to me by Officer Noel. I advised Schools that one of the individuals that she solicited for money was a police officer and that she was now under arrest. Schools was later handcuffed and placed under arrest without incident.</p> <p>Upon search incident to arrest I located the aforementioned dollar bill that Officer Noel handed Schools. The dollar bill was in a small, yellow wallet inside of School's black handbag. This dollar bill was recovered and returned to Officer Noel. Based on the above facts I believe probable cause exists to charge Caroline Schools with Panhandling/Solicitation per City of West Palm Beach code 54-147. Schools was transported to the county jail.</p>
