


| PROBABLE CAUSE STATEMENT   | <p>On the above date and time, I (Sgt. DeJoy) while on patrol in the area of 14000 Greenbriar Blvd traveling south bound within the Village of Wellington, Palm Beach County, in a fully marked PBSO patrol vehicle without a video system observed a Black 2017 Land Rover SUV tag:HJGJ43 cross over the double yellow dividing line into my lane of travel. The Land Rover over corrected and crossed over the single white shoulder line into the grass. I could clearly see the driver as a blond white female and there appeared to be no passengers in the vehicle. I observed the Land Rover through my rear view mirror speed up and recover into it's lane of travel. I conducted a U-turn and started to follow the Land Rover. I had a clear unobstructed view as the land Rover approached the intersection Greenbriar Blvd at Greenview Shored Blvd, it was traveling at a high rate of speed and made a right turn on red without stopping. See citation-(A5RHJ0E). Due to traffic the Land Rover was stopped at the intersection of Greenview Shores Blvd at South Shores Blvd where I was able to get behind it and see that the tag HJGJ43 was expired 06-17 see citation (A5RHJ1E). I conducted a traffic stop and the vehicle continued to drive into the development of EQUESTRIAN POLO VILLAGE and stopped at 13334 Polo Club Road. I walked up to the driver's side of the Land Rover and the driver put the window down. I immediately identified myself and observed her red glossy eyes and noticed slow body movements to locate her Driver's Licenses. She was identified as Carolyn Gilece. She asked me three times what she was looking for. I repeated myself all three times. She had me her Florida Driver's Licenses and continued looking for other documents. D/S Mercier arrived and started to use his in-car video system to record the stop. I requested a DUI unit and DUI 16 D/S Chiquito-Rodriguez arrived. | <p>Upon completing the roadside tasks, I advised the defendant that I concluded my DUI investigation and, based on the observational clues on the SFST's and the defendant's admission of consuming alcohol, determined that she was too impaired beyond her normal faculties to operate a motor vehicle and placed the defendant under arrest for DUI. The defendant verbally stated that she understood. I placed the defendant in handcuffs that were checked for proper fit and tightness and double locked and placed defendant in the rear of my PBSO marked patrol vehicle and transported the defendant to the B.A.T. (Breath Alcohol Testing) facility. Once at the B.A.T. the defendant was observed for a period of twenty minutes, during which time the defendant did not ingest anything, place anything in her mouth regurgitate or vomit. After the twenty minute observation period the defendant was placed on camera and asked if she would submit a breath sample for the purpose of determining its alcohol content and the defendant refused. I read the defendant Florida Implied Consent and the defendant verbally stated that she understood implied consent. I then asked the defendant again if she would submit a breath sample after being informed of implied consent and the defendant refused. The refusal was noted and documented at 2104 hours. I read the defendant her Constitutional warnings on camera and the defendant verbally stated that she understood her rights. The defendant cooperated with Q&amp;A. During Q&amp;A the defendant gave responses that varied from having consumed three glasses of wine, to having white wine and vodka, to having two bottles of wine. When asked if she could feel the effects of the alcohol, she responded "YES" and gave the same response when I asked her if she was under the influence.</p> <p>Based on the above set of facts and circumstances, probable cause exists to find CAROLYN BROOKE GILECE did drive or was in actual physical control of a vehicle, while under the influence of alcoholic beverages or chemical substances as set forth in Florida Statute 877.111, or a controlled substance as set forth in Chapter 893 or any combination thereof, and was affected to the extent that his or her normal faculties were impaired; or while having a blood alcohol level of .08 or more grams of alcohol per 100 milliliters of blood or breath alcohol level of .08 or more grams of alcohol per 210 liters of breath, contrary to Florida Statute 316.193(1). ### DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07/29/2017, at approximately 1850 hours, I responded to 13334 Polo Club Road in the Village of Wellington, located in Palm Beach County, Florida to assist Sergeant Matthew DeJoy #24986 with a traffic stop. Upon making contact with Sergeant DeJoy, he relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, the following: "On the above date and time, I (Sgt. DeJoy) while on patrol in the area of 14000 Greenbriar Blvd traveling south bound within the Village of Wellington, Palm Beach County, in a fully marked PBSO patrol vehicle without a video system observed a Black 2017 Land Rover SUV tag: HJGJ43 cross over the double yellow dividing line into my lane of travel. The Land Rover over corrected and crossed over the single white shoulder line into the grass. I could clearly see the driver as a blond white female and there appeared to be no passengers in the vehicle. I observed the Land Rover through my rear view mirror speed up and recover into its lane of travel. I conducted a U-turn and started to follow the Land Rover. I had a clear unobstructed view as the Land Rover approached the intersection Greenbriar Blvd at Greenview Shores Blvd, it was traveling at a high rate of speed and made a right turn on red without stopping. See citation-(ASRHJ0E). Due to traffic the Land Rover was stopped at the intersection of Greenview Shores Blvd at South Shores Blvd where I was able to get behind it and see that the tag HJGJ43 was expired 06-17 see citation (ASRHJ1E). I conducted a traffic stop and the vehicle continued to drive into the development of EQUESTRIAN POLO VILLAGE and stopped at 13334 Polo Club Road. I walked up to the driver's side of the Land Rover and the driver put the window down. I immediately identified myself and observed her red glossy eyes and noticed slow body movements to locate her Driver's Licenses. She was identified as Carolyn Gilece. She asked me three times what she was looking for. I repeated myself all three times. She handed me her Florida Driver's Licenses and continued looking for other documents. D/S Mercier arrived and started to use his in-car video system to record the stop. I requested a DUI unit and DUI 16 D/S Chiquito-Rodriguez arrived. DUI investigation was turned over to her."

### OBSERVATION OF DRIVER:

When I arrived on scene I observed a black Land Rover utility vehicle, bearing Florida tag HJGJ43, partially pulled in and parked at an angle of a parking space. I made contact with the driver and sole occupant of the vehicle, a female identified as CAROLYN BROOKE GILECE (defendant) DOB: 09/10/1985 by her Florida issued driver license. The driver side door was locked and the window was completely up. I tapped on the window and asked the defendant to step out of the vehicle. She glanced towards my direction and gave me a blank stare before complying with my verbal instruction. She unlocked and opened the door as she held her cellular phone in her hand. She was attempting to place a call and I when I told her to disconnect the call and place the phone down I saw her struggle with finding the correct button to end the call and fumbled dropping the phone on the center console. I could smell an overwhelming odor of an unknown alcoholic beverage emanating from within the vehicle. The defendant's eyes were red, bloodshot and glassy. I had had the defendant step out of the vehicle and she gripped the driver side door, lost her footing, stumbled taking a few steps sideways toward the rear bumper of the vehicle and almost fell over. I had to reach my hand out to her. She criss crossed and overlapped her feet and side stepped as she walked towards the front of my patrol car. With my in car video system activated, I informed the defendant what the reason for the stop was. She struggled to stand in a resting position without swaying, stumbling or leaning off balance. Her speech was slow and slurred and she was slow to respond. As she continued to speak with me an odor of an unknown alcoholic beverage emanated from her breath and became stronger as she spoke.

### DRIVER'S STATEMENTS:

I asked the defendant if she had any medical problems or was taking any medications and she denied both. I advised her that I was conducting a DUI investigation based on her level of impairment to determine if she was too impaired to operate a motor vehicle safely and she stated she understood. She stated that she was on her way home from the "Wonders Club" in "Downtown" Wellington and that while she was there she consumed two glasses of wine approximately two hours prior. The level of impairment she displayed was not consistent with only two glasses of wine. She struggled to stand without assistance. I asked the defendant if she would submit to voluntary SFST's and she consented. I used the pre painted parking space line where the surface was dry. I had to verbally tell the defendant that I would not be able to assist her with standing as she completed the tasks because she repeatedly grabbed my arm to assist with balance as she stumbled. Despite giving her multiple instruction, the defendant was unable to maintain an instructional stance without falling over.



Bloodshot, glassy eyes. She was unable to stand unassisted without stumbling over. She was unable to follow stimulus during pen/light task without turning her head so the task was not completed. Swayed in a front to back motion, rocking from heels to balls of feet, and leaned in towards me as she stood in a resting position.

**WALK & TURN:**

Instructed and demonstrated. Defendant verbally stated she understood the instructions. The defendant started task before being instructed to do so. Had to be repositioned while explaining task. She was unable to stand in the instructional stance without me assisting her. She made multiple attempts but was unable to stand with one foot in front of the other without stumbling over. She did not walk heel to toe, overlapped her feet, stumbled and stepped off line, did not count her steps out loud, maintained her arms raised more than six inches to assist with balance. She took more than nine steps forward and I had to verbally instruct her to stop because she was walking into a street. She completed an improper turn and then took more than nine steps on the return and only stopped when she reached a hedge line.

**ONE LEG STAND:**

Instructed and demonstrated. Defendant verbally stated she understood the instructions. During the instructional stance she was unable to stand with her feet together and side by side after I gave her multiple instructions and demonstrated how to do so. She completed the task with her right foot in a "ballerina" stance with her toes pointed down and rested on the ground and her arms raised more than six inches to assist with balance.

**FINGER TO NOSE:**

Instructed and demonstrated. Defendant verbally stated she understood the instructions. The defendant demonstrated proficiency with identifying her left from her right hand. During the instructional stance she was unable to stand with her feet together and side by side after I gave her multiple instructions and demonstrated how to do so. She did not maintain her head tilted back and her eyes closed. She maintained her knees bent to assist with balance but still swayed and stumbled. She never raised either hand and instead turned her head in the direction of the instruction given.

**ROMBERG ALPHABET:**

Instructed and demonstrated. Defendant verbally stated she understood the instructions. During the instructional stance she was unable to stand with her feet together and side by side after I gave her multiple instructions and demonstrated how to do so. She did not maintain her head tilted back and her eyes closed. She maintained her knees bent to assist with balance but still swayed and stumbled. She incorrectly recited the alphabet.
