PROBABLE CAUSE STATEMENT	In the city of Riviera Beach, Palm Beach County, Florida, the following incident occurred:								
	<p>On Monday November 28, 2016 at approximately 11:04 am, Officer King #6317 was dispatched to 2638 Lake Drive Apt. 2 in reference to a possible heroin overdose (C.A.D 20161128126). Upon arrival, Officer King made contact with Carolyn Griffin (W/F 06/25/1993) who reported the following:</p> <p>Griffin advised that her friend Jenna Mantovani (W/F 10/28/1990) was locked in the bathroom making strange moaning sounds. Griffin advised that Mantovani just recently overdosed on heroin and was released from the hospital in the last 24 hours. Griffin was able to make entry inside the bathroom where Mantovani was laying on the bathroom floor prior to officers' arrival.</p> <p>Officer King observed Mantovani laying on the bathroom floor with a towel wrapped around her upper body. In plain view, officers observed a syringe with an unknown brown substance inside and a piece of suspected heroin inside a bottle top located on the bathroom sink. Riviera Beach Fire Rescue responded to the scene and transported Mantovani to St. Mary's Medical Center to be evaluated.</p> <p>During the initial investigation, Officer Hawkins #6433 observed Griffin walk inside the bathroom and attempt to remove the syringe from the counter.</p>

PROBABLE CAUSE STATEMENT	<p>Griffin advised she didn't know what we were talking about, then she recanted and stated that she threw the suspected piece of heroin in the garbage can. Griffin was asked to return the suspected heroin at which time she then refused to place it back on the counter. Griffin became combative and irate towards officers at which time officers attempted to place Griffin under arrest for tampering with evidence. Griffin refused to obey commands and resisted officers by swaying her arms back and forth while Officer King attempted to place handcuffs on her. A scuffle ensued causing officers to use force to effect the arrest of Griffin. It should be noted that officers checked the area for the substance but were met with negative results.</p> <p>All photos and evidence obtained will be entered into evidence for court purposes.</p> <p>Griffin was placed under arrest for Tampering with physical evidence pursuant to Florida State Statue 918.13 (1A) and Resisting officers with violence pursuant to Florida State Statue 843.02.</p> <p>Griffin was transported to Riviera Beach Police Department for processing. Griffin was later transported to county jail without further incident.</p>
